ON NOVEMBER 28, 1978, [REDACTED]

JACKSON, ALABAMA, WAS RECONTACTED AT WHICH TIME HE ADVISED

THAT HE DID NOT HAVE THE RECORDING THAT HE HAD MADE FROM THE

PEOPLES TEMPLE IN GUYANA AND THAT THEY HAVE BEEN ERASED

FROM HIS CASSETTE. [REDACTED] FURTHER ADVISED THAT IN THE

SECOND WEEK OF AUGUST OF 1978, HE STATED THAT HE WAS INVITED

DOWN TO JONESTOWN SINCE THEY FOUND OUT THAT HE HAD A FIRST

CLASS LICENSE WITH THE FCC, WITH ALL EXPENSES PAID, WHICH

HE DID NOT ACCEPT SINCE HE HAD TO WORK AT THE RADIO STATION (u)

IN JACKSON, ALABAMA. THE PEOPLE DID NOT TELL HIM WHY THEY WANTED HIM TO COME EXCEPT FOR HIS SERVICES. (u)

[REDACTED] ADVISED THAT THE PEOPLES TEMPLE IN GUYANA HAD CONTACT WITH AN AMATEUR OPERATOR IN LOS ANGELES WHO PROVIDED A PHONE PATCH FOR THE PEOPLES TEMPLE IN GUYANA IN THE PAST. HE FURTHER ADVISED THAT THERE WAS A STATION IN TENNESSEE WHO ALSO ACCEPTED RADIO PATCHES FOR THE PEOPLES TEMPLE BUT HE COULD NOT FURNISH THE CITY IN TENNESSEE. [REDACTED] STATED THAT HE DID NOT KNOW OF ANYONE IN THE UNITED STATES THAT THE PEOPLES TEMPLE IN GUYANA HAD CONTACTED EXCEPT THAT THEY DID CONTACT A HOSPITAL IN SAN FRANCISCO WHICH HE BELIEVED TO BE SAINT MARY'S AND ASKED FOR A SURGEON SINCE SOMEONE IN GUYANA WAS SICK. HE COULD NOT FURNISH THE SURGEON'S NAME. [REDACTED] STATED THAT ALL OF THE DRUGS THAT WERE ORDERED FOR GUYANA WERE ORDERED THROUGH THE PEOPLES TEMPLE IN SAN FRANCISCO.

[REDACTED] STATED THAT HE DID NOT HAVE ANY KNOWLEDGE REGARDING A CONSPIRACY TO KILL CONGRESSMAN RYAN AND DID NOT KNOW OF ANYONE WHO WAS INVOLVED IN THIS MATTER. (u)

[REDACTED] STATED THAT HE HAS TO PAY DUES TO THE AMERICAN RADIO RELAY LEAGUE INCORPORATED AT NEWINGTON, CONNECTICUT. THE PRESIDENT IS HARRY J. DANNALS AND THE SECRETARY IS RICHARD L. BALDWIN. [REDACTED] STATED THAT THEY MONITOR THE AMATEUR'S FREQUENCIES AND STATED THAT IT IS POSSIBLE THAT SOME OFFICIAL OBSERVER ON 20 METERS THROUGH THE AMERICAN RADIO RELAY LEAGUE INCORPORATED MAY HAVE TAPED THE CONVERSATIONS FROM THE PEOPLES TEMPLE IN GUYANA. (u)
