DETAILS: "RYMUR" is code name for Bureau-wide special involving investigation of the murder of Congressman Leo J. Ryan, 11/18/78, in Jonestown, Guyana. Bureau investigation is focusing on determining whether or not a conspiracy existed between members of the Peoples Temple Church in the United States and followers in Guyana, as set forth in the Congressional Assassination Statute. In view of the fact nationwide leads are expected and Congressional interest in this matter, a special major case number for TURK purposes is deemed necessary. *(u)*
