During coordination of captioned matter in its earlier stages, FBIHQ received information in the form of unsubstantiated comments from unknown sources that United States fugitives may have been associated with the Peoples Temple settlement in Guyana. (u)

On 11/22/78 review of ticklers maintained by Fugitive Unit, FBIHQ, disclosed four Bureau fugitives who have been previously located in Guyana. (u)

IT IS EMPHASIZED THAT THERE IS NO KNOWN CONNECTION BETWEEN THESE FUGITIVES AND THE PEOPLES TEMPLE. (u)
