IN JANUARY, 1973, INTERVIEWEES MOVED TO GLOBE, ARIZONA, WHERE THEY REMAINED UNTIL NOVEMBER, 1974, WHEN THEY WERE GRANTED PERMISSION BY JONES TO RETURN TO CALIFORNIA. DURING THIS PERIOD OF TIME INTERVIEWEES CONTRIBUTED FINANCIALLY TO THE PEOPLE'S TEMPLE CHURCH.
