[REDACTED] STATED THEY AT ONE TIME WERE TOLD ALL EX MEMBERS AT SOME POINT IN TIME WOULD BE KILLED AFTER THEY LEFT THE PT AND HEARD PLAN WAS IN FACT FORMULATED TO KILL UNKNOWN PUBLIC OFFICIALS. SPECIFIC DETAILS OF THESE PLANS UNKNOWN TO [REDACTED] TERRY BUFORD (PHONETIC), WHITE FEMALE, AND CLOSE CONFIDANTE OF JONES, ALLEGEDLY POSSESSES THIS LIST. (u)

[REDACTED] STATED SHRIMP BOAT OF PT "CUDJOE" OPERATED BY CAPTAIN PHILLIP BLAKELY AND TIM SWINNEY. THIS BOAT NOT AT JONESTOWN DURING SUICIDE INCIDENT, BUT ON TRIP OBTAINING SUPPLIES AND ENDED UP IN TRINIDAD WITH HELEN SWINNEY, CHARLES TOUCETTE, PHILLIP BLAKELY AND RICHARD JANERO. CONTACT WITH HELEN SWINNEY AT 9:30 A.M., NOVEMBER 26, 1978, CONFIRMED SHE WAS IN TRINIDAD BUT THAT BOAT HAD GONE BACK OUT TO SEA WITH OTHER THREE INDIVIDUALS TO UNKNOWN DESTINATION. (u)
