THE BOAT WAS ALSO INSTRUCTED TO TURN OFF THEIR RADIO AND TURN IT BACK ON EVERY 15 MINUTES. THE BOAT WAS ALSO TOLD THAT THERE WAS AN AMERICAN SHIP IN THE VICINITY WHICH COULD REACH THEM WITHIN TWO OR THREE HOURS. THE BOAT

THE DISSATISFACTION b7C APPEARED TO HAVE BEEN GOING ON FOR A MONTH OR A LITTLE LONGER PRIOR TO NOVEMBER 15. 1978. THERE WAS A LOT OF TALK ABOUT THE PEOPLE IN CHARGE AND WHAT THEY WERE DOING AND WHAT THEY WERE BEING TOLD. DID NOT KNOW WHAT THIS REFERRED TO. DID NOT KNOW OF REVEREND JIM JONES AND DID NOT KNOW HE WAS IN GUYANA UNTIL AFTER NOVEMBER 18, 1978. KNEW THEY WERE TRANSMITTING FROM JONESTOWN. HE SAID ONE PERSON WHO WAS EITHER THERE OR SUPPOSED TO GO TO GUYANA

SOME OF THE DISSATISFACTION STEMMED FROM THE FACT THAT THE PEOPLES TEMPLE IN GUYANA WASN'T RECEIVING THE SUPPLIES THEY ORDERED AND NEEDED. IN PARTICULAR REMEMBERS SHOVELS AND HOSES. SOMETIME IN OCTOBER OF 1978 REMEMBERED AN ORDER FOR FIVE GRAMS OR KILOGRAMS OF STRYCHNINE, 10,000 SYRINGES. HE ALSO RECALLS PAST CRDERS FOR PENICILLIN, DARVON, TIRES, FARM EQUIPMENT, HOSE CLAMPS. SHOVELS AND OTHER SUCH EQUIPMENT. ADVISED OVER THE PAST FIVE MONTHS THERE WERE TREMENDOUS AMOUNTS OF ORDERS PLACED FOR DRUGS FOR GUYANA. NEVER HEARD ANY ORDERS PLACED FOR GUNS BUT STATED IT COULD HAVE BEEN DONE BY SOME TYPE OF CODE. MANY ORDERS WERE MADE USING PART NUMBERS ADVISED THAT THERE APPEARED TO BE A LOT OF BICKERING BETWEEN GUYANA AND SAN FRANCISCO AND HE OVERHEARD ONE TRANSMISSION DURING THE WEEK OF NOVEMBER 15, 1978, STATING THAT THEY, PEOPLE AT GUYANA WEREN"T GOING TO FOLLOW A DIRECTIVE. STATED HE DID NOT KNOW WHAT THE DIRECTIVE WAS.
