ATTEMPTING TO EXPOSE, DISCREDIT, OR ARREST THE CHURCH'S 20 LEADER, JIM JONES. IT IS ALSO ALLEGED THAT WEAPONS WERE 18 SHIPPED FROM THE PEOPLE'S TEMPLE IN SAN FRANCISCO TO GUYANA AND THAT POSSIBLE CONSPIRATORS IN THE UNITED STATES MAY HAVE BEEN DIRECTED BY CODED RADIO COMMUNICATIONS FROM JONESTOWN

TO TEMPLES IN SAN FRANCISCO AND LOS ANGELES. [W]

SAN FRANCISCO IS REQUESTED TO ASSUME ORIGIN IN THIS MATTER AND CLOSELY COORDINATE WITH THE OFFICE OF THE UNITED STATES ATTORNEY IN AN ATTEMPT TO SECURE SEARCH WARRANTS FOR THE PEOPLE'S TEMPLES IN SAN FRANCISCO AND LOS ANGELES TO RETRIEVE ANY EVIDENCE WHICH MAY SHOW A CONSPIRACY TO VIOLATE THE CONGRESSIONAL ASSASSINATION STATUTE. ALL LEADS IN THIS MATTER ARE TO BE HANDLED BY TELEPHONE AND FOLLOWED BY IMMEDIATE TELETYPE. W
