Aug 6, 78 1:58 AM to 2:40 AM. The Station

you referred to paying 732 was WB6M10/8R3  
in Guyana South America. They are

250 miles in the jungle from Georgetown

Guyana. The Country between Venezuela  
and Surinam.

I have been monitoring them since  
Sept 1977 along with a fairley large  
group of US hams as well as the F.C.C. They  
are a secretly orginazation known as "The  
Peoples Temple Church" out of San Francisco, Ca.

They usually, when conditions permit, have an  
inter-com with their sister station WD6DV1

in San Fran. and WB6MNH/8R1 in Georgetown

Usually they use women operators, real sexy

voices on both ends. They handle traffic related to their operator in a coded, cypher, form that don't make sense. They have operated outside of the band - above 14350 which no country allows hams to use. The F.C.C. has lowered the boom on San Fran when operated under WB6DTS. The license of WB6DTS turned in his ticket to F.C.C. but is still to answer charges of international violations. They handle traffic such as orders for supplies + equipment and checks with prices in the thousands of dollars. This is forbidden in the ham band.

The leader of the church is Jim Jones who can be heard over WB6MID/8R3 and goes under the name of Al Touchette. He is a number one con man who has enticed 1,200 people to join him in building a town on 2,000 acres in the jungle. The people are former drug addicts, mis-fits and run-aways who we think are being used as slave labor to build his town.

There is a group of concerned parents in California who are trying to get their kids back and are accusing Jim Jones of holding them captive in "Jones Town".

All of the operators you hear on 14341 are well educated people from California. They QSY frequently to get a clear frequency. 14341 is their starting freq. and they operate all night. I have monitored as late as 5 AM EDT. The State Department has

filed three major complaints in the last 9 months to the Guyana Govt. to investigate cruelty. They tell me - State -

that "you know the place is so hard to get to and you have to go there under prior arrangements that the Govt finds ~~the~~ everything OK by the time they arrive."

Another Violation — They go over the 10 minute period for station I.D.

Jim Jones is reported to have 10 million bucks stashed away in various banks.
