DRUG ENFORCEMENT ADMINISTRATION (DEA) HEADQUARTERS,
WASHINGTON, HAS REQUESTED THAT SURVIVORS AND PEOPLES TEMPLE
MEMBERS IN THE UNITED STATES WHEN INTERVIEWED BE QUERIED
CONCERNING ALLEGED DRUG TRAFFICKING BY THE PEOPLES TEMPLE IN
GUYANA. DEA DESIRES THE FOLLOWING QUESTIONS BE ASKED:
