OF JONESTOWN, IN GUYANA, AND THE ACTIVITIES WHICH TOOK PLACE DURING FIFTEEN MONTHS JONESTOWN HAD BEEN IN EXISTANCE. SHE SAID IT MENTIONED, ALTHOUGH SHE COULD NOT RECALL SPECIFIC DETAILS, THAT (A) PT HAD AN "ASSISSINATION GROUP" WHICH WOULD KILL PT DEFECTORS (B) THE U. S. GOVERNMENT WAS OUT "TO GET" PT (C) FINANCIAL DEALINGS OF PT (D) STOCK PILING OF ARMS BY PT, AND (E) WAYS IN WHICH PT MEMBERS AND THEIR CHILDREN WERE MISTREATED AT JONESTOWN. (u)

[REDACTED] ALSO TOLD [REDACTED] HE HAD SHOWED THIS DOCUMENT TO VICE PRESIDENT MONDALE AND CONGRESSMAN RYAN IN AN ATTEMPT TO GET U. S. GOVERNMENT TO INVESTIGATE PT. HE ALSO TOLD HER THAT THE "NATIONAL ENQUIRER", A WEEKLY NATIONAL NEWSPAPER, HAD INDICATED IT WOULD PUBLISH THIS DOCUMENT BUT EVENTUALLY REFUSED TO DO SO. (u)
