TOLD [REDACTED] THAT JAMES JONES HAD ESTHER MUELLER SIGN SOME PAPERS IN GUYANA WHICH RESULTED IN \$7 MILLION GOING INTO A SWISS BANK ACCOUNT IN MRS. MUELLER'S NAME. LANE STATED THAT MRS. MUELLER WAS DEFINITELY AMONG THE DECEASED IN THE JONESTOWN INCIDENT AND THAT [REDACTED] IS AN APPARENT HEIR TO THE \$7 MILLION. LANE HAS URGED [REDACTED] TO FLY TO MEMPHIS TO "SIGN SOME PAPERS". (u)

LANE CLAIMS HE HAS DEFECTED FROM THE PEOPLES TEMPLE GROUP AND WANTS TO ASSIST [REDACTED] IN ACQUIRING THE ABOVE-DESCRIBED MONEY. LANE IS, AT THIS TIME, ARRANGING A FLIGHT SCHEDULE AND HAS TOLD [REDACTED] HE WILL PAY FOR THE TICKETS, ENABLING [REDACTED] TO TRAVEL TO MEMPHIS. LANE HAS INSISTED THAT [REDACTED] DOES NOT DISCUSS THIS SITUATION WITH ANYONE. (u) [REDACTED] TELEPHONICALLY CONTACTED THE INDIANAPOLIS OFFICE BECAUSE HE FEELS ENDANGERED AND IS RELUCTANT TO TRAVEL TO MEMPHIS IN FEAR OF HIS LIFE. [REDACTED] HAS NOTED PRESS ACCOUNTS INDICATING THERE MAY BE SOME VALIDITY TO THE INFORMATION SUPRA. (u)
