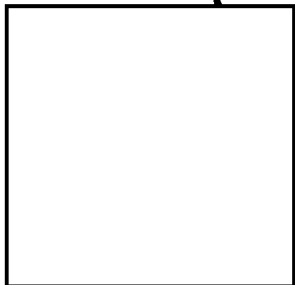

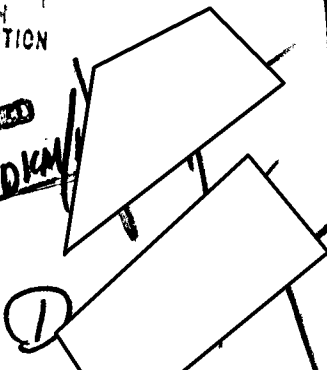

[REDACTED] STILL HELD THE RANK OF LIEUTENANT IN THE GUYANA NATIONAL SERVICE. NUMEROUS CORRESPONDENCE WITH LEGAT CARACAS INDICATES THAT THE GOVERNMENT OF GUYANA WAS AFFORDING PROTECTION TO THESE INDIVIDUALS AS "BLACK POLITICAL REFUGEES" FROM UNITED STATES. (u)

[REDACTED] ADVISED THAT ACCOMPANYING HER GRANDSON IN JONESTOWN, GUYANA, WAS HER NIECE, MARGARET JONES, A BLACK FEMALE APPROXIMATELY FIFTY-NINE YEARS OF AGE. SHE ADVISED THAT SHE HAS NOT RECEIVED ANY WORD REGARDING HER NIECE TO AS DECEASED. SHE ADVISED THAT THIS INDIVIDUAL HAD A STOMACH OPERATION SEVERAL YEARS BACK AND THAT SHOULD MEDICAL RECORDS BE NECESSARY FOR IDENTIFICATION OF THE BODY DOCTOR [REDACTED] OF SAN FRANCISCO, CALIF., FURTHER ADDRESS UNKNOWN, WOULD BE ABLE TO FURNISH RECORDS, ALSO NEIGHBOR, [REDACTED] SAN FRANCISCO, CALIF., TELEPHONE NUMBER [REDACTED] COULD FURNISH NAME OF DENTIST WHO ATTENDED MARGARET JONES.
