A SURVIVOR OF THE GUYANA TRAGEDY. PEARSON FORMERLY LIVED IN CALIFORNIA AND WAS A MEMBER OF THE PEOPLES TEMPLE (PT), AND WAS NOT ALLOWED TO LEAVE CALIFORNIA, ALTHOUGH SHE APPARENTLY WANTED TO, UNTIL HER DAUGHTER DIED IN FLORIDA AT WHICH TIME PEARSON WAS ALLOWED TO ATTEND THE FUNERAL AND REMAINED IN FLORIDA. AFTER PEARSON'S BREAK-A-WAY FROM THE PT SHE BECAME FEARFUL AND WOULD NEVER DISCUSS HER PAST ACTIVITIES WITH THE PT AND DID NOT WANT HER CURRENT

IN ANOTHER PART OF GUYANA OR IN TRINIDAD. EXACT DETAILS UNKNOWN. (u)
