PROPERTY AMOUNTING TO \$135,000 IN MAY 1977. THIS APPEARED TO BE A VIOLATION OF CALIFORNIA STATE LAW 487.1 PC AND 519 PC (EXTORTION). (u)

THE [REDACTED] WERE ACTIVE PT MEMBERS FROM 1971 UNTIL THE SUMMER OF 1977, DONATING 25 AND 50 PERCENT OF THEIR TOTAL NET SALARIES TO THE PT. IN FEBRUARY 1977, THE [REDACTED] WERE ASKED TO COME TO THE OFFICE OF JIM JONES LOCATED IN THE CHURCH ON ALVARADO STREET IN LOS ANGELES. PRESENT DURING THIS CONFERENCE WERE JONES, HIS TOP AID, MC ELVANE, HUGH FORTSYN, FLORIDA JOHNSON, VEE HOLLINGS, KAY NELSON, RESIDENCE [REDACTED] LOS ANGELES, AND ARCHIE IJAMES. JONES TOLD THE [REDACTED] THAT THEY WOULD HAVE TO SELL THEIR HOMES AND GIVE THE MONEY TO HIM OR THEY WOULD DIE; HE WOULD KILL THEM. THE [REDACTED] REFUSED AND JONES AGAIN THREATENED THEM BY SAYING A PT MEMBER WHO DID NOT CONTRIBUTE TOWARDS THE TEMPLE DIED AS A RESULT OF THAT NEGLIGENCE. MR [REDACTED] STATED HE WAS UNDER EXTREME PRESSURE AT THE TIME AND BECAUSE OF THE THREATS, AGREED TO SELL THEIR PROPERTIES. BOTH PIECES OF PROPERTY WERE SUBSEQUENTLY LISTED BY THE ENOLA M. NELSON REALTY, LOS
