At 2:22 p.m. this date, San Francisco Office advised that San Francisco Mayor George Mosconi and City Supervisor Harvey Milk were shot and killed in the Mayor's Office by an individual identified as Dan White. The shooting, which occurred at approximately 2:15 p.m., Eastern Standard Time, apparently is not related to captioned matter, but rather, is the outgrowth of a political argument over whether White could withdraw his resignation as City Supervisor and be reinstated by the Mayor. White, a city fireman, apparently became enraged at the Mayor's decision to appoint another individual to take White's place and shot both individuals. White is in local custody at this time. San Francisco is endeavoring at this time to determine if Dan White has ever had any association with the Peoples Temple **REC- 102**

former member of the Planning Commission of the Peoples Temple, has furnished information to the San Francisco Office that the Peoples Temple is made up of four types of persons. These types include ex-members, current members, members of the Planning Commission, and "the Angels" or "Staff" who are the innercircle of the Planning Commission. The Angels have been characterized as the "hit men" by ex-members who have been interviewed. Ex-members have also indicated the existence of a contingency plan which would go into effect under the following conditions to include the following results: (W) 22 DEC 5 1978

If a public official attempted to expose the Peoples Temple, Angels were to kidnap the public official's children, kill those children, kill their own children, and then commit suicide (U)

If the Church fell, the following persons are to be assassinated: San Francisco Mayor Mosconi, the President of the United States, and the Governor of California.

named were those in line to succeed to the Presidency. The foregoing information has been made available to local officials in California as well as the Justice Department. United States Secret Service (USSS), CIA, State Department, National Security Agency, Defense Intelligence Agency, and the White House Situation Room. (W)

Telephonic contact with Legat Robert Ogelsby has revealed that the Guyanese Police have taken appropriate steps to preserve and protect all physical evidence in Guyana which includes 32 weapons listed by Guyanese and furnished to the FBI for NCIC checks. NCIC is negative re all weapons and this information is being relayed to Guyana for the information of local authorities. (W)

It has been determined that the briefcase belonging to Congressman Ryan was given by DCM Richard Dwyer, State Department Official in Guyana, to James Schollaert, a Committee Staffer for Congressman Ryan. Schollaert has returned to his home in Virginia, and is being interviewed by the Alexandria Office. (N)

Medical records and various unidentified tape recordings located at the Jonestown community are in the possession of the American Embassy at Georgetown, Guyana. The State Department intends to turn these documents over to the FBI unless the Government of Guyana insists upon retention of those items for prosecution in Guyana. In the latter event, all materials will be copied for the FBI before the originals are turned over to the Government of Guyana. / W)

The current status of Americans in Guyana is as follows:(U)

A6 individuals are in residence at the Lamaha Gardens, Peoples Temple Headquarters in Georgetown, Guyana. This is the location where Sharon Amos and her three children were murdered at about the same time the mass suicide took place in Jonestown. It is recalled that the Lamaha Gardens is a Peoples Temple owned structure in Georgetown, Guyana.

29 individuals are currently housed at the Park Hotel. This group is composed of those formerly listed as the group who elected to stay at Police Headquarters s before being persuaded to go to the hotel. Included in this group are

two brothers named Carter and Michael J. Prokes who were at one time held by local police but who have since been released. Local authorities appear convinced that these individuals were not involved in either the airport incident or the mass suicide. (χ)

Two individuals are in a public hospital; one individual, Miguel DePina was allowed to return to the United States on a commercial flight due to advanced age and ill health. Mr. DePina is being interviewed at Los Angeles following his arrival there on this date. (2)

authorities in Guyana. Larry Layton has been charged with murder. Layton was born on Layton has been charged with the murder of Congressman Ryan although it is unclear as to whether he actually shot Ryan personally. The second individual being detained by local authorities is Charles Beikman who has been charged with the murders of Sharon Amos (supra) and her children. Beikman was born 8/13/35 in Indiana. No further information is available at this time regarding these arrests other than the fact that Larry Layton is scheduled to go to trial in Guyana on 1/15/79. No trial is yet set for Charles Beikman. (N)

The identities of all persons travelling in the Ryan party both to Georgetown and to Jonestown is now known. We are insuring that all of these individuals are promptly interviewed. We are attempting to identify all members of the news media who are either in Guyana or who have returned from Guyana during the period of this incident. State Department has advised that they do not have a list of media personnel and we probably will be forced to rely upon media publications in order to identify all representatives of the media for interviews. The San Francisco Office has arranged through the Office of the United States Attorney, San Francisco, for the New York Office to purchase from NBC News, New York, a copy of film footage of the events at the crime scene. The costs, which will be borne by the United States Attorney's Office, San Francisco, should only amount to the costs of reproduction of the film. We have deemed this action more expedient than seeking the issuance of a subpoena which would undoubtedly involve a lengthy court battle in which NBC would no doubt feel compelled to challenge the subpoena to protect its industry.

A teletype has been sent to all offices and Legats this date advising of the legitimate interest of USSS and instructing that these interests be accommodated.

The investigation into the background of Dr. Larry Schacht has begun. Dr. Schacht is believed to be the individual who was the medical officer at the Jonestown community who prepared the suicide laced Koolaide from which many victims drank. A file review by the Houston Division indicates prior investigation of Schacht and family members regarding Students for a Democratic Society (SDS) activities and former Communist Party USA connections. This matter is being followed closely to insure that the background investigation is limited to Dr. Larry Schacht and not to other family members where not shown to be pertinent to the showing of a criminal violation. Alcohol, Tobacco, and Firearms Division of the United States Treasury Department has undertaken the task of tracing the Jonestown weapons for the FBI

Attached for information is an affidavit in support of arrest warrants for individuals charged in this matter with violations of the Congressional Statute (18USC351(a) and (d)). It is expected that the persons named in these arrest warrants will be served at Charleston, South Carolina, if they return from Guyana.

Investigation continuing. W
