THE SUMMARY TELETYPE PROVIDES INFORMATION WHICH SHOULD BE FURTHER CLARIFIED BY ADDITIONAL INVESTIGATION SET FORTH IN THE ABOVE TEL WITH ADDITIONAL LEADS REGARDING THE INTERVIEW OF CHARLES TOUCHETTE TO FOLLOW BY SEPARATE TELETYPE.
