ON DEC 5, 1978, SOURCES AT CII ADVISED THAT CHARGE AGAINST JONES OF LUDE CONDUCT IN HIS DEC 13, 1973 ARREST AT LOS ANGELES WAS DISMISSED ON FEB. 1, 1974. SOURCES ALSO ADVISED THAT ON JAN. 31, 1974, THE LAW FIRM OF BALABAN, BERMAN, SELAN, AND STEWART, 8920 WILSHIRE BOULEVARD, BEVERLY HILLS, FILED A MOTION IN LOS ANGELES MUNICIPAL COURT REQUESTING AN ORDER FOR THE SEALING OR DESTRUCTION OF ALL RECORDS PERTAINING TO JONES AND HIS 1973 ARREST. SOURCES AT CII INDICATE THAT THE RECORD HAS NOT BEEN SEALED AT THIS TIME. THIS IS POSSIBLY DUE TO THE LACK OF THE ISSUANCE OF A FINAL COURT ORDER. (u)
