Dear Sir: Leo Ryan

During one of the news broadcasts from  
Jonestown S. America I heard that all the passports  
of the members were found by the army locked  
up in a large trunk. This poses several questions  
in my mind. (1) If these persons in Jonestown  
and in the San Francisco Church are not being  
forced against their wills, then why were their pas-  
ports and personal property taken from them and  
locked up. Christ never taught force or aggression  
in the salvation of souls. (2) Why haven't these  
passports been released to your agents in (u)  
Doner Delmore who are attempting to identify  
these bodies. If they had those passports it would  
certainly be far more easier for your agents  
In fact I have a <sup>DE-2</sup> ~~third~~ question (3) Why has the  
U.S. State Department been more cooperative with  
your agents and given them, your agents their  
pictures etc of the bodies? I know you are a  
religious man and neither God or Christ give  
adults the right to murder small young children  
For this reason alone that cult in  
San Francisco should be investigated. Children  
in the cult have a Constitutional right and a God  
given right to the salvation of their souls. God  
gives them that free will and no human qualifies

to take from a child those rights which God and Country gives them. No I am not a religious bigot and yes I do support Constitutional Rights of freedom of religion and having mothered 3 children I know how easily their pure minds can be influenced. People who use brute force to worship God do not know God. No human has ever matched the perfection of Christ nor will they ever. And Christ warned us of hurting little ones.

Christ said It would be better that you have a socket around your neck and throw into sea than to hurt one of the least of these my little ones. Christ left the 90 and 9 to save one last soul and we as a nation are not going to do a criminal investigation for the murder of 187 of these innocent little ones.

This whole tragedy does not appear to me to be mass suicide pact. So many were murdered in cold blood like the 30 missionaries in Rhodesia who were murdered. I can't help but wonder if there is not an international threat to American missionaries. I talked one with Rev. Conway Wickham Council of Churches about the persecution of the missionaries in Spain. I was hoping he would tell me it was not true but he said every word you say was confirmed by a missionary friend of mine who just returned from Spain. There it was a Military Gov't and the Catholic Church who were persecuting non Catholics worse than in Communist Countries. The Army forced them to join the army. Then they were ordered to go to Catholic Mass. At the elevation

of the ~~rest~~ <sup>3</sup> of Christ they had to stand and give  
a gun salute. The United States must never  
have a military-Industrial Gov't which  
General Eisenhower condemned in inaugural  
speech part of which was quoted in 'Seven Days  
In May'. Such misplaced power he said  
will destroy democracy and freedom.

Another case a City persecuting an Amish  
family because they refused to send their 16 year  
old daughter to high school. The girl was  
attending a trade school and was taking a  
Correspondence course but this did not satisfy  
the bureaucracy that town. First they arrested the  
father fined him and threw him in jail.

Then when I heard they were auctioning their  
farm I wrote Governor Hughes and requested  
he help the family. Asking what had happened  
to freedom of religion in the United States.

The Governor took up their cross and helped  
these people. Then a group of them decided to

he was paid by politicians to be large crowds  
to political affairs to give a T.V. Camera the  
illusion that the Candidate really had a large

following of supporters. <sup>4</sup> Rev. Jim Jones must have been paid well for this since they found several millions of dollars and gold in that country in S. America.

There is another racket operating in U.S. Minister's licenses are issued by mail for \$1.00. Many persons have obtained such licenses not to preach the Bible but to set up a thriving business. Example made by Mrs. Mary O'Hara. As you know she once had a suit in court to force Roman Catholics to pay taxes on all property they owned but church and parsonage. Someone told her about this racket. So she ordered her Minister License made her husband a Bishop and then bought large Commercial Bldg from a woman, then rented the office back to them and nobody paid until some taxes because she protected under the guise of a church which she called St. Little Richards Church. I believe this was in Texas near San Antonio.

This is especially dangerous to the security of the United States since foreign buyers can purchase property in U.S. and when they do they don't even have to pay Capital gains taxes on their property or profits. I was working for General Motors during World War II making Carbines M-1 and M-16 and even as far back as then General Motors was publishing booklets on our next war.

which they said would be an economic war and  
your predecessor in "Matters of Secret" said  
America will be destroyed from within and  
with foreign buyers who operate like U.S.  
India with hidden ownership most certainly  
will buy America right out from under our  
children and grandchildren. There is no  
way for anyone to find out just what foreign  
person or agency is buying this property.  
It is not registered in their names but in

 France. Was made Bishop of Tours. Martin destroyed

Letter I received from D.C. Division in answer to  
one I wrote Pope Paul VI, the signature on that letter  
when requested would Will back was Martin  
I went back to 11th because of St Martin of Tours  
who taught St. Odo. now I should like to take  
you back to 1972 election. On Nov 16th Feast  
of St. Edmund of Canterbury - General of Louisiana  
Edmund Edwards and former U.S. Congressman  
On this date of 16th 1972 the two students were  
shot and killed on New Orleans College Campus  
Smith and Leonard. On the same date I had  
been given an expt at D.C. General. I cancelled  
the appointment when I heard of the murder and  
the transfer to Court of D.C. Jail inmate. There  
was already custody or note at D.C. Jail when  
I had appointment at D.C. General. The Grand  
jury investigated and reported D.C. Jail Guards  
were being bribed. Also on Nov 16th in  
the Diocese of New Orleans only there are  
celebrations for anticipation of Our Lady of  
Guadalupe. The actual Feast Day of Our  
Lady of Guadalupe is on Dec 12. On that  
Date I had an expt in D.C. General Neuro-  
surgery Clinic which I again cancelled when  
I heard that a longshoreman in Bitternase, given  
broken neck by police in arrest had died.  
There were also note that day in Richmond  
State prison and they called for Congressman  
Launtroy. On Nov. 17, 1972 The students  
marched in protest of the slaying Smith and  
Leonard, while here in the District I wrote a letter  
of protest to City Councilman Sterling Tucker protesting  
the police shooting in back of Gregory Coleman  
16 year old who was killed by a Black Police  
officer who still remains on force today. Gregory  
had his bike stolen the night before. Gregory was

shot in back in the police set up. Then in  
January on Feast of St John Bosco Saint of youth  
a police officer by the name of Gregory was shot  
St Gregory was a doctor of the Catholic Church  
and who the Gregorian Chant is named after.

The date of Jan 31st. was when J. Edgar Hoover stopped  
space flight, the one which later failed. That date

Richard Nixon was on the Island of St John  
making the eunuch Sylvester Bernard. The  
Medical Report from Walter Reed on John  
Stennis was also released. He was head of  
Defense Committee then. The Court proved conspiracy  
in his shooting. When Selznick was released  
he went to and participated in Gregorian Mass.

Nov. 19th is Feast of St. Elizabeth of Hungary  
where Cardinal Mindszenty is. He under hypnosis  
revealed all of the Church secrets. Queen Elizabeth  
II went to Israel filled with wrath on the  
announcements of the sinking of Titanic. Princess

Anne married Capt Mark Philip of Stoker  
Army. In my hometown of Easton Ohio the  
Church of Visitation of Mary to her cousin Elizabeth  
Mrs Betty Gard Elizabeth was in white dress my  
sister to whom I sent a Protestant Will Jones  
Hanson, her name is Elizabeth Close. My  
Grandmother name was Elizabeth and my Aunt  
my mother in law name was Elizabeth Gross

Confirmed in Catholic Church after divorce taking  
name of Mary's mother Anne. Now we are taken  
by the name Anne back to Georgetown Hospital  
Teddy Kennedy Jr was admitted on Thursday. On  
Saturday ~~he~~ removed his leg for cancer. I believe  
decision was made too quickly. The Indians  
get new members now by religious ceremonies

Senators Kennedy asked from interview Carl to give  
 only Roberts daughter away in marriage. That  
 day Georgetown was supposed to play Carroll  
 Arbor Michigan and I charged foul play in  
 both the game and the hospital. Georgetown then  
 played Catholic U. and Anne Arbor played Ohio  
 State and the game was thrown to Ohio State  
 a man even said he was going to court over  
 the decision. In Homelons Catholic Church priest  
 name is Vogel. Dr. Vogt went to (25 mile east)  
 Health Dept Director and Bishop Vogel followed  
 me to Kansas.

I noticed in the spec in Jonesville that it  
 was a mixed congregation recently and I still  
 believe there was far more than mass suicide  
 involved there. Congressman Ryan notified the  
 U.S State Department of alleged torture in Jonesville  
 one year before the deaths and the only questions  
 that were ask were by paper boys Airforce officers  
 requested family to send Dental charts medical  
 records and pictures to identify the dead. I  
 repeat again the state Dept is failing these  
 victims because they have all the information  
 on Passport records so why should family have  
 to answer their requests if State Dept was  
 cooperating with the Airforce? Since the  
 Guyana Army went in the compound and  
 found all the passports locked up in a trunk  
 why haven't they released this private American  
 citizens property? Something really wrong when  
 officials do not cooperate with your FBI  
 agents and Airforce.

I recall Armen recent trip to S. America before this happened. As well as Mrs. Ghordi's trip to England who once owned Guyana. I recall also the four hundred Armen was supposed to have ~~executed~~ executed in Cold Blood and the U.S. memoraries 30 of them killed in Rhodesia by Nationalist. This is when the Salvation Army withdrew their membership in World Council of Churches because W. Corrie donated \$80,000 to the Black Nationalist who committed those mass murder. In both areas Boston once owned them 60 min last Sunday C. B. S also had two evangelists in who like Jim Jones were making Millions of dollars. The timing told me that Jim Jones was not the only man involved in those murders. I believe these deaths are part of the racial war of Mafia depopulation there 50% of East India (from India 31% of African descent 12% mixed descent 4% American Indian) former slaves were brought in to work plantations as well as indentured servants from India. The Andean son antinumbered the Negro population and still do. Venezuela has claimed possession of the Western half of Guyana in 1970 this claim was suspended for 12 years. The Guianan Bauxite is the largest industrial business there based in the manufacture of Bauxite which is used in manufacture of aluminum. The population there was interested like Jones Company but Jim Jones helped elect Jimmy Carter, Norr Billy Graham got \$12,000

of 2.3 million people to the White Protestant Church which  
split from Jimmy Carter's Church when a Black man  
tried to join. Just exactly how I am not certain  
but those people were murdered because State Dept  
officials did not do their jobs properly. Seemed  
a little strange to me that Jim Jones could have  
been minister so long and still had only about  
1,200 membership in church. 300 there  
and several hundred at San Francisco  
church. I personally believe that U.S. State  
Department needs to be cleaned out. Congress-  
man Ryan and the reporters all died because  
in a year or two the U.S. State Dept did not  
honor the requests of Congressman Ryan  
and just asked out not releasing important  
information and now making it very  
difficult not only for your men but also for  
trying to identify the bodies.  
A Catholic Sister received Peace award in  
England a year or so ago and \$50,000  
for her work in India  
I personally cannot see how State Dept of peace  
and President can live with this innocence  
because of their Bureaucratic bungling. The  
Honorable Ryan sacrificed his life trying to  
save the other 300 and the reporters. There were  
human beings who died there not 300 machines.  
Look at the stench made about St. Calley and  
the massacre at My Lai why do American  
citizens deserve less? There is a real sickness in  
certain department of U.S. Govt. a Terminal Cancer  
which is killing the soul of America why when a  
Christian Congress chose this executive cabinet. The  
Christian Church is worthy of men one human life



One of the police officers in Eaton had a friend  
in Cincinnati who was F.B.I. Agent, who told  
the Eaton officer there was a dock strike in N. York  
when I mailed those letters to Rennie Radio Moscow  
Correspondent and Pope Paul VI in 1969. I do not  
believe they ever left Eaton when I mailed them  
in March 1969. They were returned stamped  
New York Embargo I took them to police  
Eaton and ask why since there was no  
Dock Strike in New York. The F.B.I. stated  
there was. But I took the same letters put them  
in new envelopes again with correct postage  
and mailed them in Dayton, Ohio the following  
day. They were not returned and it was after  
that the police called me and said F.B.I. friend  
said they had been stopped because of dock strike. Dock  
Strike would not affect air mail. I wrote Rabbi  
Ackerman and sent him one of those envelopes  
stamped New York Embargo and wrote to T. V. News  
Media. Two weeks after they were returned  
the Dock Strike was reported on news. I also wrote  
Postmaster General Blount then. His son  
had manslaughter charges dropped against him in  
the fatal death of his wife and Congress responded  
by raising postage (regular) to Russia making it  
same as airmail to make it appear I did not send  
letters airmail. By this time the Pope and Russia  
had already received the letters. Before I forget. Sheriff  
Stone (now retired) Preble Co. I visited no office in Eaton  
and caught at me, and Jack as he was calling I am  
metron and Sheriff of Eaton & Mont. Co. I was  
Mafia is strong in Ohio and Richmond Ind. where  
Jens Jones and family will be buried. It is in Preble  
Co. Preble Co. Richmond or Ohio State line, Greenville, Ohio  
Hamilton Consider all of these areas. My friend  
Bernardin discharges. It is also in Columbus  
town Toledo (what I believe) of Embargo at Election time.

gave me a bad time when I told them I could  
not pay lump sum of taxes on V. A property  
I sold in 1959 on 2nd mortgage 12 year. I  
agreed to pay it monthly but they said don't  
worry. It was Dayton S.B. and Secret Service  
& emptied paper out of bank box and went  
to head office of S.B. S then in Cincinnati  
and made arrangements to pay them all of  
the mortgage check of \$25.00 per month until



the tapes were <sup>up</sup> paid. This is concrete proof & should have a good credit rating but I don't  
The only time my name was ever on mortgage  
Cause I hate credit and do not have charge  
acc't. If I want anything I either send the money  
or buy it or pay away or on 90 days I am out  
Cash I do not have income either then or now  
to pay these high interest rates. U.S. Wage  
and Hours did not enforce minimum wage  
for waitresses. I worked in Wichita for \$5.00  
per shift. A nice business store either tried to  
be nice to me or frame me. I put \$2.00 on  
dress till payday the dress was \$15.00. When I went  
to get it they insisted that I had an \$85.00 coat  
all paid for. "This is your signature" It  
did look like it but I demanded the manager  
and he took said the \$85.00 coat belonged to  
me. I left with my \$15.00 dress. I never knew  
if it was attempted ~~charity~~ or frame. Detective  
Wichita Police Dept seemed to be attempted to  
me up for bad checks other people Danis in Wichita  
write and there were to be people Danis in Wichita  
the District Atty of Sedgewick Co even had me  
derriving a Danis in Wichita before I ever  
leaved there. Cleo or Leo or some such name. My  
name is Joseph Wade Danis Sr. Postmaster Blount who  
he was in P. Office Department Contracted to build new  
P.O. all over the U.S. and was connected with the  
Index in Iowa the one who killed the Granddaddy. Rumor  
had it Senator Galbreath son of mine was up in that one.  
after Senator Galbreath lost election for President he  
came to Wichita and had closed down meetings  
when they emerged they were demolishing several

blocks between Broadway in Douglas  
to Railroad and the owner of Eaton Hotel where I  
lived in for three years the owner sold half of  
it and agreed to renovate it to original state  
The life size Portrait of Carrie Nation was re-  
moved. It was later Ben she smashed.  
The new owner was Philip Cassebaum who  
was married to Alf Landon's Daughter  
Nancy. I understand she is legally separated  
from Philip now when she won the U.S Senate  
seat recently. I knew her personally. I  
worked on Rockefeller Campaign with her.

Somebody Your Honor is examining my  
private medical records in Dexter Ohio  
of the 1950's without a letter of written Consent  
from me required by both Ohio State Law  
and D.C. Law. I know they are because they  
are harping about low back pain. Nobody  
in D.C. has ever treated me for low back pain  
and nobody else has since the lady G.D.'s  
The pain I feel now is above the waste  
line but for right leg + arm. The arm broken  
in myssery and the leg broken on ice on  
St Mary's Cathedral steps in Wichita. The low back  
pain has turned to resedulness from Surgery  
Such evidence is not least admissible and is the  
same as Stealing Confidential records and transporting  
them property across state lines. No body can legally  
use medical and medical records against me they  
are by law Confidential. This date of information

began after the President attended the Democratic  
Jackson Day dinner in Columbus Ohio  
where Mr Hoover said Columbus police Detective  
were accepting bribes when Robert Kennedy  
was killed. That same week of Jackson  
day dinner the President sent his wife  
and mother to Kansas and Wichita  
to try to find skeletons in my closet.

There is more most of the time I lived in  
Wichita I went to Church daily until it  
became mandatory I leave Catholic Church  
for reasons of conscience. They had attempted  
to arrest me the day Pope Paul VI passed  
in New York. Charges were dropped and  
Blanch Detetive Henderson was killed in auto  
accident. Agent William Carr took my purse  
Three members of St Mary's were witnesses and  
told me. Dr. William Carr, Army psychologist  
was appointed to Horton Prison Army Hospital  
and shortly thereafter an inmate died. The next  
was after a letter I received from President Johnson  
which was in that purse. I had submitted the  
name of Conrad Jensen N.Y. retired police  
Detective working with Army address as a replace-  
ment for Dr Hoover when he retired or died when  
I reported same to police I was told they could  
not get it. I had been in many U.S. Cities but  
D.C. is the only city I had ever been mugged and  
robbed in there and that has happened here 5 times

in 6 1/2 years, the first time was on  
the Feast of St Gaspard Precious Blood, the saint  
the Precious Blood Fathers were celebrating the  
day they gave the three part sermon  
accusing Priest and Gov't officials of  
corruption and being Judases for a few pieces  
of silver. The Priest said it happened first on  
Calvary and again when Rome fell. All of this  
is why I know these attacks are not racial.  
Blacks are involved as Uncle Toms and  
dupes like the Mau Mau were of Black & white  
in old Waukegan when Bethel Monasteries were  
bombed by U.S because they were hiding Hitler  
spies. And when U.S rebuilt it in 1964 Pope  
Paul VI said "They rebuilt it as if we could  
forget."
