DOCTOR ORE STATED THAT PREVIOUS TO THIS, HE HAS APPEARED ON LOCAL TELEVISION TWICE IN REGARDS TO INTERVIEWS OF THEIR FURNISHING MEDICAL ASSISTANCE TO THE GUYANA COMMUNITY AND IN THE SECOND INTERVIEW, HE WAS INTRODUCED AS A DOCTOR DONALD ORE, A DENTIST WHO WAS PRACTICING IN FLOSSMOOR, ILLINOIS. (u)

DOCTOR ORE WAS ADVISED TO IMMEDIATELY CONTACT THE CHICAGO HEIGHTS AND FLOSSMOOR POLICE DEPARTMENTS AND ADVISE THEM OF THE ABOVE AND REQUEST ADDITIONAL PATROLS BY HIS PLACE OF BUSINESS AND RESIDENCE, WHICH HE STATED HE WOULD DO IMMEDIATELY. (u)
