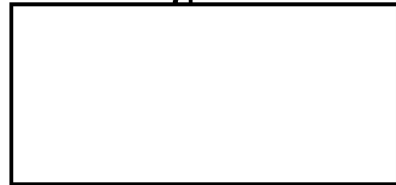

TELEPHONE PATCHES TO CALIFORNIA, BUT [REDACTED] WOULD NOT HELP THEM. (u)

UB6MID HAS BEEN IN CONTACT BY DIRECT AMATEUR RADIO WITH THE PEOPLE'S TEMPLE IN SAN FRANCISCO. HE HAS HEARD THEM TALKING ABOUT A DOCTOR WHO GRADUATED FROM U OF CALIFORNIA, BUT DID NOT DO INTERNSHIP. ABOUT THE LAST TRANSMISSION TWO MONTHS AGO, THE COMMUNE ORDERED HOSPITAL SUPPLIES AND GAVE NOMENCLATURE AS IF ORDERING FROM A MEDICAL CATALOG. THEY ORDERED FORCEPS, SCISSORS, CLAMPS, GAUZE, SPLINTS, MOTORS, GENERATORS, ETC. ON ONE PREVIOUS OCCASION, THEY ORDERED TEN THOUSAND PAIRS OF SOCKS. (u)

[REDACTED] HAD TALKED TO THEIR OPERATORS, WHO WERE WOMEN. ONCE THEY CAME ON THE AIR AND SAID A WOMAN WAS GOING TO HAVE TWINS, AND ONE WOULD BE BREACH BIRTH. [REDACTED] RELAYED BETWEEN THE COMMUNE RADIO STATION AND KFZP, WHO IS A DOCTOR, FOR INSTRUCTIONS. (u)

THE COMMUNE'S RADIO STATION OPERATORS USED NUMEROUS NAMES PRECEDED BY THE WORD DOCTOR. [REDACTED] THINKS THAT THIS WAS A CODE, BECAUSE SOME OF THE COMMUNICATIONS DID NOT MAKE SENSE. SOME TIME AGO, [REDACTED] CALLED FCC MONITOR STATION IN WASHINGTON, (u)

D. C., AND COMPLAINED ABOUT THE COMMUNE'S COMMERCIAL TRAFFIC AND CODE. THE FCC GAVE [] THE IMPRESSION THAT THEY WANTED THE MATTER LEFT ALONE. HE WAS TOLD THAT FCC WOULD PREFER HIM NOT TO MENTION THE STATION IN AMATEUR RADIO. AFTER TALKING TO FCC [] THOUGHT THAT THE COMMUNE WAS A GUERRILLA GROUP OR ELSE THE CIA WAS INVOLVED. HE PREVIOUSLY HAD ONE TAPE OF THE COMMUNE'S COMMUNICATIONS, BUT ERASED IT AFTER TALKING TO FCC. (u)

[] ATTEMPTED TO MONITOR THE STATION THE DAY HE HEARD THAT CONGRESSMAN RYAN WAS KILLED, BUT DID NOT HEAR ANYTHING.

[] ADVISED THAT RON LNU, WHO IS OFFICIAL OBSERVER FOR AMATEUR RADIO RELAY LEAGUE, LOS ANGELES, CALIFORNIA, CALL SIGN WBSYID, HAS MONITORED THE GROUP ON NUMEROUS OCCASIONS. (u)
