COL. SCOTT, U. S. AIR FORCE, OFFICE OF DEFENSE LIAISON AT  
THE STATE DEPARTMENT, WASHINGTON, D. C., HAS PROVIDED INFOR-  
MATION TO FBIHQ THAT RADIO TRANSCEIVERS FOUND AT JONESTOWN,  
GUYANA, WERE FLOWN BY MILITARY TRANSPORT TO MAC DILL AIR FORCE  
BASE, TAMPA, FLORIDA. IT WOULD APPEAR THAT THIS EQUIPMENT IS  
SIGNIFICANT EVIDENTIARY MATERIAL IN THIS CASE. THEREFORE,  
TAMPA SHOULD OBTAIN THE TRANSCEIVERS FROM MAC DILL AIR FORCE  
BASE AND FORWARD SAME TO SAN FRANCISCO AS OFFICE OF ORIGIN.
