FOR ADDITIONAL INFORMATION LOS VEGAS, MR. AND MRS. MOORE 20 HAVE STATED THEY HAVE MADE NUMEROUS ATTEMPTS TO OBTAIN THE 18 TRUTH REGARDING THEIR DAUGHTERS' DEATHS IN GUYANA FROM VARIOUS GOVERNMENT AGENCIES. THEY APPARENTLY HAVE HAD SOME FRUSTRATING 16 CONTACTS WITH THESE AGENCIES RESULTING IN A SOMEWHAT SUSPICIOUS ATTITUDE ON THEIR PART.
