FOR ADDITIONAL INFORMATION LOS VEGAS, MR. AND MRS. MOORE
HAVE STATED THEY HAVE MADE NUMEROUS ATTEMPTS TO OBTAIN THE
TRUTH REGARDING THEIR DAUGHTERS' DEATHS IN GUYANA FROM VARIOUS
GOVERNMENT AGENCIES. THEY APPARENTLY HAVE HAD SOME FRUSTRATING
CONTACTS WITH THESE AGENCIES RESULTING IN A SOMEWHAT SUSPICIOUS
ATTITUDE ON THEIR PART. THEY HAVE REQUESTED THE PRESENCE OF AN
INDEPENDENT PATHOLOGIST AT ANY AUTOPSY OF THEIR DAUGHTERS'
REMAINS BUT HAVE BEEN ADVISED THAT NO PATHOLOGIST IN DELAWARE
WOULD BE WILLING TO HANDLE THIS ASSIGNMENT. THIS REQUEST STILL
HAS STANDING WITH MILITARY PERSONNEL AT DOVER AIR FORCE BASE
AND WOULD PRESENT PROBLEMS SHOULD THEY AUTHORIZE THE AUTOPSIES
OF THEIR DAUGHTERS' REMAINS. THEREFORE, THE CONTACT WITH THE
MOORES SHOULD BE HANDLED BY EXPERIENCED AGENTS AND THE ISSUE OF
THE INDEPENDENT PATHOLOGIST SHOULD BE DISCUSSED. THE MOORES
SHOULD BE ADVISED THAT THE FBI IS INTERESTED IN THE OBJECTIVE
TRUTH SURROUNDING THE MURDER OF CONGRESSMAN RYAN AND RELATED
MATTERS AS ARE PERSONNEL AT DOVER AIR FORCE BASE IN CARRYING
OUT THEIR PARTICULAR RESPONSIBILITIES. THE MOORES SHOULD BE
REQUESTED TO WITHDRAW THEIR REQUEST FOR AN INDEPENDENT PATHOLO-
GIST'S PRESENCE DURING THE AUTOPSIES AND IF POSSIBLE, OBTAIN
