ACCOUNTS INDICATE THAT THE CONGRESSMAN AND HIS PARTY MET WITH 20THE REVEREND JIM JONES AND OTHER CHURCH LEADERS/MEMBERS IN 18 JONESTOWN. THE MEETING WAS ARRANGED THROUGH ATTORNEYS FOR THE PT. IT IS UNCLEAR WHAT DISCUSSIONS TOOK PLACE BETWEEN THE 16 CONGRESSMAN AND CHURCH MEMBERS. 
