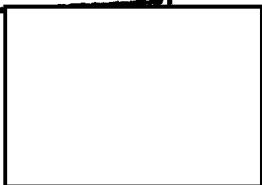

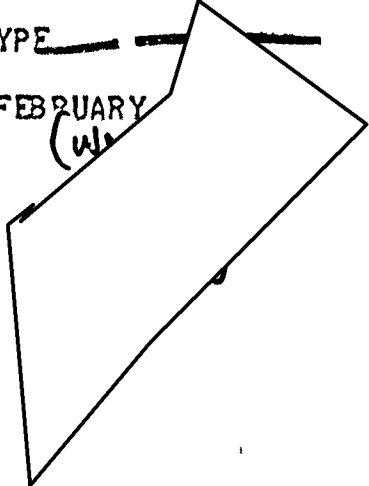

LOS ANGELES INDICES ALSO CONTAINED REFERENCE IN LOS ANGELES FILE 48-0-1311 DATED AUGUST 1976 UNDER NAME JIM JONES AND THE PTDC. REVIEW OF THIS REFERENCE DETERMINED THAT ON AUGUST 6, 1976, A MICHAEL J. PROKES, ASSOCIATE MINISTER, PTDC, SAN FRANCISCO, CALIFORNIA, SUBMITTED A LETTER TO FBI, LOS ANGELES, WHEREIN IT WAS STATED THAT A [REDACTED], WHOSE WIFE WAS A MEMBER OF THE PTDC, HAD BEEN MAKING THREATENING STATEMENTS AGAINST THE PTDC AND HAD CLAIMED TO HAVE REPORTED SAME TO THE FBI. LETTER REFERS TO THE FACT [REDACTED] IS CONSIDERED MENTALLY UNBALANCED AND THAT HIS ACCUSATIONS SHOULD BE CONSIDERED "RIDICULOUS LIES". ABOVE MENTIONED LETTER WAS SUBSEQUENTLY FORWARDED TO THE SAN FRANCISCO
