FURTHER, INDICES CONTAIN NO PERTINANT INFO RE LEO J. RYAN. HOWEVER IT WAS NOTED THAT RYAN, ALONG WITH NUMEROUS OTHER OFFICIALS, JUDGES, ECT RECEIVED A THREATENING LETTER, (OCTOBER, 1977) FROM [REDACTED] A PROLIFIC LETTER WR ITER; SACRAMENTO OFFICE OF ORGIN. THE PURPOSE OF [REDACTED]'S CORRESPONDANCE APPARENTLY WAS IN CONNECTION WITH HIS VIEW THAT HE HAD BEEN IN JUSTLY CHARGED IN A DRUG RELATED ARREST AND INJUST INCARCERATION OF HIS FRIEND [REDACTED] ON THE DRUG CHARGE.
