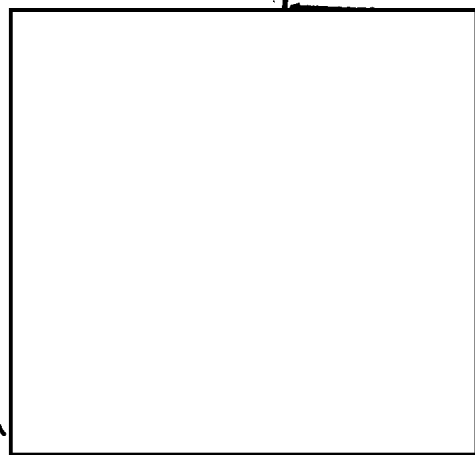

[] AGAIN TELEPHONICALLY CONTACTED [] TO ADVISE HE MERELY NEEDED [] AUTHORITY TO ENABLE [] TO NOTIFY THE SWISS BANKS TO FREEZE THE ACCOUNTS.
