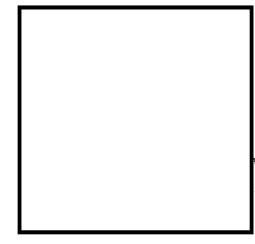

2) ON NOVEMBER 17, 1978, STEVEN ADVISED TEAM HE WOULD NOT RETURN TO JONESTOWN UNDER ANY CIRCUMSTANCES. AS A RESULT, THE TEAM STAYED WITH INDIVIDUAL KNOWN AS "SNAKE" GUYANESE NATIONAL WHO OPERATES A KARATE GYM OR SCHOOL IN GEORGETOWN. ADDITIONALLY, ON NOVEMBER 16, 1978, STEVEN JONES WAS INDIVIDUAL WHO GREETED LATE CONGRESSMAN RYAN UPON HIS ARRIVAL IN GEORGETOWN. (u)

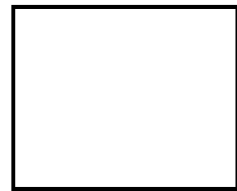

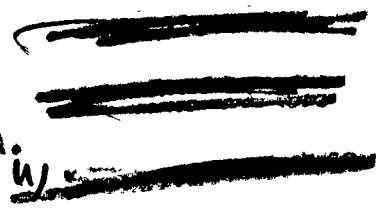
