NUMEROUS PRESENT AND FORMER PEOPLES TEMPLE MEMBERS CURRENTLY IN THE UNITED STATES HAVE BEEN INTERVIEWED BY THE UNITED STATES SECRET SERVICE AND FEDERAL BUREAU OF INVESTIGATION. IT IS THE STRONG OPINION OF THE SECRET SERVICE THAT SEVERAL KEY MEMBERS CURRENTLY IN GUYANA MUST BE INTERVIEWED TO PROPERLY ASSESS THE DEGREE OF DANGER THAT THIS GROUP MAY PRESENT TO THE PRESIDENT OF THE UNITED STATES AND OTHER PERSONS PROTECTED BY THIS SERVICE.

THIS SERVICE HAS NO OBJECTION TO GUYANESE OFFICIALS OR ANYONE ELSE THAT THAT THEY DESIRE BEING PRESENT DURING THESE INTERVIEWS.
