[] INDICATED SHE HAS NO SPECIFIC INFORMATION REGARDING BRIBERY OF PUBLIC OFFICIALS, HOWEVER, INDICATED THAT JONES HAD ADVISED PC THAT HE HAD SEVERAL PEOPLE WHOSE SOLE PURPOSE WAS TO ENTRAP INFLUENTIAL AND PUBLIC OFFICIALS FOR FUTURE BLACKMAIL PURPOSES. (u)

[] INDICATED THAT SHE HAD PARTICIPATED IN ONE SUICIDE DRILL APPROXIMATELY SPRING, 1976. (u)
