PAGE 2 CONTINUATION SHEET PAGETIMO DE RUEHFB 0024 UNCLAS FBIHQ HAS BEEN ADVISED OF THE DISTINCT POSSIBILITY THAT 20 CERTAIN SURVIVORS OF THE ASSAULT AND MASS SUICIDE AT JONESTOWN, 18LGUYANA MAY LEAVE GEORGETOWN BY WAY OF COMMERCIAL AIR TRANS-PORTATION. THEREFORE, THESE PERSONS WOULD NOT BE INTERVIEWED 16 BY THE FBI TEAM AWAITING ARRIVAL OF SURVIVORS IN CHARLESTON -SOUTH CAROLINA. IT IS IMPERATIVE FBI BE ADVISED OF THE IDENTITY 14 OF THOSE SURVIVORS LEAVING GUYANA BY COMMERCIAL AIRLINES, THEIR _DESTINATION, AND ESTIMATED TIME OF ARRIVAL IN ORDER TO EFFECT NOT TYPE PAST THIS 12 AN INTERVIEW OF THESE PERSONS.
