MEMPHIS HAS INTERVIEWED LANE ON NUMEROUS OCCASIONS REGARDING BUFORD AND LANE HAS INDICATED HE REPRESENTS HER AND WOULD ONLY MAKE HER AVAILABLE IF SHE WERE GRANTED IMMUNITY FROM PROSECUTION. USA, SAN FRANCISCO, AND ATTORNEY MARK LANE ARE CURRENTLY NEGOTIATING IN AN EFFORT TO RESOLVE DIFFERENCES WHEREAS BUFORD WILL BE AVAILABLE FOR INTERVIEW. (u)
