DETAILS: On 12/7/78, [redacted], Bureau of Inter-American Affairs, State Department, advised Liaison Officer [redacted], that [redacted], who indicated she is affiliated with the U. S. Labor Party <sup>and</sup> a publication called "Executive Intelligence Review" telephoned him on 12/5/78. She related that she has some information regarding the former husband of [redacted]. The exhusband reportedly is a marksman and served as a mercenary in Angola in 1974-75. "Executive Intelligence Review" has published information regarding cults, including articles on Peoples Temple subsequent to the tragic events in Guyana. [redacted] said she is located at [redacted], N. W., [redacted], Washington, D. C., telephone numbers [redacted] and [redacted].
