Per referenced telephone call, Alexandria was requested to interview [redacted], [redacted] Leesburg, Virginia, in connection with a telephone call she had made to a Legislative Assistant to a Congressman in connection with the assassination of U. S. Congressman LEO RYAN, 11/18/78. (u)

On 11/28/78, [redacted], [redacted], Leesburg, Virginia, was contacted and she advised that for whatever benefit it might be, her neighbor [redacted] telephone number [redacted], a Real Estate Saleswoman for Glasscock Realty, Leesburg, Virginia, related to her that Congressman RYAN had an appointment with Glasscock Realty in Middleburg, Virginia, for 10:00AM on 11/18/78, in connection with some land which RYAN was considering purchasing. Ms. [redacted] was not aware as to whether RYAN might have cancelled this appointment prior to his departing for Guyana, W
