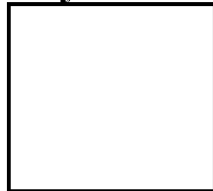

SAN FRANCISCO SHOULD CONDUCT INTERVIEWS OF ALL THESE INDIVIDUALS IF NOT DONE SO ALREADY, PARTICULARLY [REDACTED] [REDACTED], WHO CLAIMED JIM JONES WAS PHYSICALLY VERY SICK. THE INTERVIEWS DISCUSS CONDITIONS AT JONESTOWN AND P.T. IN GENERAL. THESE FILMS SHOW NO EVIDENCE OF A CONSPIRACY TO ASSASSINATE RYAN, NOR ARE ANY OTHER FEDERAL CRIMES MENTIONED. (u)
