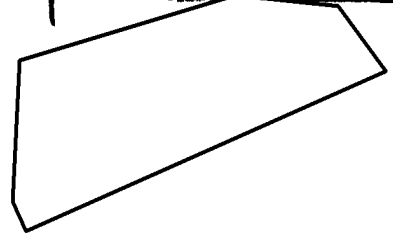

RYAN IS NOT LIVING AT 1213 E CAPITOL STREET, S.E., WDC, AND NO ONE IS USUALLY HOME TO ANSWER THE PHONE, NEGATING THE USEFULNESS OF THE SYSTEM. WASHINGTON FIELD CONCURRED (u)

ON DECEMBER 11, 1978, DETECTIVE [REDACTED] FIRST DISTRICT METROPOLITAN POLICE DEPARTMENT (MPD), ADVISED THAT A COMPLAINT WAS RECEIVED FROM A NEIGHBOR OF [REDACTED] [REDACTED] IN WDC THAT SHE HAD HEARD NOISES COMING FROM [REDACTED] RESIDENCE, [REDACTED] ON NOVEMBER 25, 1978. OFFICER [REDACTED] OF THE FIRST DISTRICT, SUBSTATION 1, RESPONDED AND FOUND NO EVIDENCE OF A CRIME. NO REPORT WAS MADE OF THE INCIDENT. [REDACTED] LEGAL COUNSEL, THE WASHINGTON POST, ADVISED THAT KRAUSE IS CURRENTLY IN GUYANA. WASHINGTON FIELD HAS NOTED ADS IN THE WASHINGTON POST FOR A BOOK PUBLISHED BY KRAUSE AND HIS EYEWITNESS ACCOUNT OF THE INCIDENT AT THE PORT KITUMA AIRSTRIP. (REFER TO BUREAU TELETYPE TO WASHINGTON FIELD, DECEMBER 1, 1978, SAN FRANCISCO TELETYPE TO BUREAU, DECEMBER 5, 1978.) IT IS ALSO NOTED THAT [REDACTED] RAISED THE ISSUE OF CONFIDENTIALITY OF THE PRESS, AND IT WAS POINTED OUT THAT THE FBI WAS AWARE OF THIS; HOWEVER, KRAUSE WOULD BE INTERVIEWED AS THE WITNESS TO A CRIME.
