DEPARTMENTAL ATTORNEY MICHAEL ABBELL ADVISED THAT THE  
DECEMBER 8, 1978, NEW YORK TIMES INDICATED IN AN ARTICLE THAT  
GUYANESE POLICE COMMISSIONER BACKER STATED THAT UNITED STATES  
AND GUYANESE CURRENCY IN THE AMOUNT OF \$2,500,000 WAS FOUND  
IN A CHICKEN COUP AT JONESTOWN. THIS MONEY ALLEGEDLY INCLUDES  
THE \$500,000 RECOVERED IN THE SUITCASE AND AN ADDITIONAL \$2  
MILLION FROM THE CHICKEN COUP. LEGAT ADVISE IF THE NEWSPAPER  
ARTICLE REPORTING THE RECOVERY IS ACCURATE AND FROM WHERE  
CURRENCY WAS RECOVERED. SUTEL.
