REVENGE, BOTH POLITICAL AND PERSONAL, WERE RESPONSIBLE. HE IDENTIFIED THESE PEOPLE AS [REDACTED] AND STATED THEY WERE NOT ABOVE MAKING TELEPHONE CALLS AROUND THE COUNTRY IN FURTHERANCE OF THESE MOTIVES. HE MADE FURTHER ACCUSATIONS THAT THE BUREAU WAS BEING MANIPULATED AND MISUSED BY THESE PEOPLE AND REQUESTED A FEDERAL BUREAU OF INVESTIGATION (FBI) INVESTIGATION INTO THE SOURCE OF THESE ALLEGATIONS.
