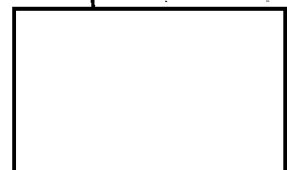

BUREAU ADVISED BY AIRTEL DATED, DECEMBER 8, 1978, THAT FBI HEADQUARTERS LIAISON OFFICER, UNITED STATES DEPARTMENT OF STATE, [REDACTED] WAS INFORMED BY [REDACTED] [REDACTED] BUREAU OF INTER-AMERICAN AFFAIRS, UNITED STATES DEPARTMENT OF STATE ON DECEMBER 7, 1978, HE HAD BEEN TELEPHONICALLY CONTACTED ON DECEMBER 5, 1978, BY [REDACTED] WHO INDICATED SHE WAS AFFILIATED WITH THE U.S. LABOR PARTY AND A PUBLICATION CALLED THE "EXECUTIVE INTELLIGENCE REVIEW". SHE HAD INFORMATION REGARDING [REDACTED] [REDACTED] REPORTEDLY IS A MARKSMAN AND SERVED AS A MERCENARY IN ANGOLA IN 1974-75. "EXECUTIVE INTELLIGENCE REVIEW" HAS PUBLISHED INFORMATION REGARDING CULTS, INCLUDING ARTICLES ON THE PT SUBSEQUENT TO THE TRAGIC EVENTS IN GUYANA.

[REDACTED] TELEPHONICALLY CONTACTED WASHINGTON FIELD AND ADVISED SHE WAS WITH THE SECURITY SECTION OF THE U.S. LABOR PARTY IN NEW YORK AND WAS CALLING IN RESPONSE TO A PRIOR INQUIRY BY WASHINGTON FIELD AT THE U.S. LABOR PARTY IN WASHINGTON, D.C. [REDACTED] SAID THAT SA [REDACTED] (PH) OF THE NEW YORK OFFICE HAD CONTACTED [REDACTED] ALSO OF THE SECURITY SECTION OF THE U.S. LABOR PARTY IN NEW YORK, SHORTLY AFTER THE JONESTOWN INCIDENT AND SA [REDACTED] HAD BEEN VERBALLY BRIEFED ON INFORMATION AVAILABLE TO THE U.S. LABOR PARTY. THE U.S. LABOR PARTY HAS SEVERAL DOCUMENTS THEY BELIEVE WOULD BE OF VALUE TO THE FEDERAL BUREAU OF INVESTIGATION, WHICH WOULD BE AVAILABLE FOR PURCHASE, REGARDING THE PT, OTHER CULTS OF A POTENTIAL NATURE, DRUG SMUGGLING BY THE PT, AND [REDACTED] THE U.S. LABOR PARTY IS ALSO WILLING TO FURNISH UNPUBLISHED MATERIAL IN THEIR POSSESSION, REALIZING THE "LIMITED INTELLIGENCE CAPABILITIES AVAILABLE TO THE FEDERAL BUREAU OF INVESTIGATION UNDER THE GUIDELINES."
