Declaration re Jonestown

I, Larry Lee Litke, declare and say as follows: I am an American, a citizen of California, and that I am 84 years old. I am a retired attorney. In March, 1980, I wrote an article entitled "The Downfall of Jim Jones", which may be googled at the San Diego State University website.

In the evening of November 17, 1978, I telephoned my friend George C. Souza in Red Bluff and told him that my other friend David Conn said (predicted) there would soon be a mass suicide and murder in Jonestown, Guyana. On a couple of previous occasions I had mentioned David's private investigation of the crooked preacher, Jim Jones, to George. David and I both ~~thought~~ <sup>believed</sup> Congressman Leo Ryan was in deadly danger. So I thought it would be interesting and possibly useful to tell George Souza about David's bizarre prediction of mass suicide. Of course, George was astounded, especially when David's prediction became true the next day, November 18. I think ~~George~~ <sup>George</sup> called me back then. Naturally, George told his wife, <sup>Mary</sup> what I said about David Conn's foresight and prediction. Both George (age 79) and Mary (age 68) are still alive. David is 91. I either phoned George on November 17 from my home or from David's hideout in San Pablo and George lived in the Red Bluffs, California area. I met George in 1964 when he was a Deputy Sheriff and I was a Deputy District Attorney in Tehama County. Later George became a contractor in Red Bluff, then a teacher at Vacaville State Prison.

David Conn's prediction of mass suicide <sup>and</sup> murder at Jonestown and the death of Congressman Leo Ryan is covered at pages 22 to 24 in my aforesaid article, "The Downfall of Jim Jones".

I declare, under penalty of perjury, that all of the foregoing is true and correct. Executed on July 10, 2019, at Moraga, California 94556.
