SUBJECT: AMERICAN CITIZENS IN GUYANA SETTLED NEAR VENEZUELAN BORDER
REF: ARA/NC (DEVINE) MEMCONS OF MAY 21 AND MAY 29; GEORGETOWN 0931

1. IN RESPONSE TO DEPARTMENT AND EMBASSY CARACAS INTEREST, POST HAS DEVELOPED FOLLOWING INFORMATION ON TWO GROUPS OF U.S. CITIZENS, PEOPLE'S TEMPLE AGRICULTURAL MISSION AND SHALOM COOPERATIVE, WHICH HAVE SETTLED IN GUYANA NEAR VENEZUELAN BORDER.
2. PEOPLE'S TEMPLE AGRICULTURAL MISSION: THIS MULTI-RACIAL GROUP CONSISTS OF NINE AMERICANS WHO OPERATE AGRICULTURAL SETTLEMENT THREE MILES FROM PORT KAITUMA IN NORTHWEST DISTRICT OF GUYANA, APPROXIMATELY TWENTY-FIVE MILES FROM VENEZUELAN BORDER. LINKED WITH PEOPLE'S TEMPLE OF DISCIPLES OF CHRIST, CALIFORNIA BASED RELIGIOUS GROUP, PEOPLE'S TEMPLE AGRICULTURAL MISSION APPEARS WELL ORGANIZED AND FINANCED AND HAS LEASING ARRANGEMENT WITH GCG. THEY HAVE RECENTLY PURCHASED TRAILER FROM U.S. SHRIMPING COMPANY AND EXPECT TO SUPPLEMENT AGRICULTURAL WORK WITH FISHING. MEMBERS OF PEOPLE'S TEMPLE ARE FAVORABLY KNOWN TO EMBASSY AND HAVE TOLD CONSULAR OFFICERS THAT THEY EXPECT ADDITIONAL TWENTY TO TWENTY-FIVE SETTLERS IN NEXT TWO MONTHS. THEY DECLINE TO SPECULATE ON FUTURE SIZE, BUT POINT OUT THAT SPONSORING CHURCHES IN CALIFORNIA HAVE APPROXIMATE TOTAL MEMBERSHIP OF 10,000, OF WHICH ONLY SMALL ELEMENT WOULD BE POTENTIAL SETTLERS HERE.
3. SHALOM COOPERATIVE: THIS GROUP, ALSO MULTI-RACIAL, IS LOCATED

APPROXIMATELY EIGHT MILES FROM PORT KAITUMA AND CONSISTS OF TWENTY-SIX AMERICANS. IN CONTRAST WITH FIRST GROUP, THEY ARE INEXPERIENCE!

POORLY ORGANIZED, LACK FIRM LEASING ARRANGEMENT WITH GOG, AND RECENTLY HAVE EXHAUSTED THEIR FINANCIAL RESOURCES. COOPERATIVE APPEARS TO BE SPLITTING UP AND ONE MEMBER HAS ASKED FOR REPATRIATION TO U.S. (REPTEL)). IN RESPONSE TO QUESTION BY CONOFF, ONE GROUP MEMBER SAID THERE ARE NO RPT NO THIRD COUNTRY NATIONALS INVOLVED IN COOPERATIVE.
