

SUBJECT: DYMALLY VISIT TO GUYAKA

1. LT. GOV. DYMALLY DURING HIS VISIT TO GUYAKA HELD A SHORT PRESS CONFERENCE ON DEC. 28. REPORTED IN DAILY CHRONICLE ON DEC. 29 DYMALLY ANNOUNCED TO PRESS THAT HE PLANS TO URGE DEPARTMENT TO WORK TOWARDS GOOD RELATIONS WITH CARIBBENA COUNTRIES. ARTICLE REPORTED THAT DYMALLY INTENDS TO MEET WITH THE QUOTE STATE DEPARTMENT CARIBBEAN DESK UNQUOTE SOMETIME AFTER CARTER INAUGURATION.

2. DYMALLY WAS ALSO QUOTED AS SAYING THERE WAS BASIC GOODWILL IN THE CARIBBEAN TOWARD U.S. AND THE QUESTION IS WHETHER THE U.S. WANTS TO PURSUE A POLICY REFLECTING THIS GOODWILL. DYMALLY CONTINUED THAT THERE WAS GREAT MISUNDERSTANDING BETHEEN THE LIMITED OFFICIAL USE

DESTABILIZATION IN THIS REGION

PRESIDENT-ELECT CARTER BEFORE THE NOVEMBER ELECTIONS AND WAS GIVEN
ASSURANCES THAT THE U.S. UNDER A CARTER ADMINISTRATION WOULD NOT
INTERFERE IN THE DOMESTIC AFFAIRS OF OTHER NATIONS.

- 3. REMAINDER OF ARTICLE DEALT WITH DYMALLY'S BACKGROUND AND PURPOSE OF TRIP WHICH WAS TO VISIT PEOPLE'S TEMPLE AGRICULTURAL MISSION AT PORT KAITUMA. DYMALLY IS SCHEDULED TO MEET TODAY WITH PRIME MINISTER AND ATTEND A LUNCHEON HOSTED BY DEPUTY PRIME MINISTER.
- CHARGE MET WITH DYMALLY FOR SHORT PERICO UPON HIS ARRIVAL IN GEORGETCHN DEC 27 AND AGAIN FOR LONGER PERIOD ON DEC 28. BISHOP JIM JONES. LEADER OF PEOPLE'S TEMPLE CHRISTIAN CHURCH. WAS ALSO PRESENT AT SECOND MEETING WHEN CHARGE SUMMARIZED PRESENT STATE OF U.S.-GOG RELATIONS. CHARGE EMPHASIZED TO BOTH DYMALLY AND JONES USG ANGER OVER BURNHAM'S OCT 17 SPEECH WHEN BURNHAM IMPLIED U.S. COM-PLICITY IN CUBANA AIRLINE CRASH DESPITE REPEATED ASSURANCES OF U.S. non-involvement from highest level of usg. Charge continued that RECENT HARSH GOG RHETCRIC IN LOCAL PRESS AND OTHER FORA CHARGING U.S. WITH DESTABILIZATION OF GUYANA AND CHARACTERIZING U.S. AS ENEMY HAS FURTHER HAMPERED NORMALIZATION OF RELATIONS. JONES AND DYMALLY BOTH STATED THAT THEY HAD MET ON DEC. 28 WITH FORMIN WILLS WHO EXPRESSED FEAR THAT USG HOULD DESTABLIZE GUYANA LIKE HE DID CHILE. JONES ALSO INDICATED THAT THERE WAS REAL FEAR AMONG GOG THAT CIA WAS SUPRANATIONAL AGENCY ANSWERABLE TO NO ONE. WHO WERE ACTING AGAINST GUYANA UMBEXMONNST TO OTHER AGENCIES OF USG. CHARGE CATEGORICALLY DENIED ANY AGENCY OF USG INCLUDING CLA HERE ACTING AGAINST GUYAKA. CHARGE INDICATED THAT GUYANESE SIMPLY REPUSE to believe our denials even though they have no evidence on OH THE CONTRARY. GOG WHICH TO BASE THESE FEARS AND ACCUSATIONS. RECENTLY HAS GONE CUT OF ITS HAY TO BE ABRASIVE IN ITS RELATIONS CHARGE THEN STATED PROBLEM IS WHY IS GOG BEEMINGLY with U.S. SO HOSTILE ESPECIALLY SINCE THERE DOES APPEAR TO BE GENUINE REGARD LIMITED OFFICIAL USE olimited official use

5. DURING COURSE OF CONVERSATION JONES APPEARED TO QUESTION CREDIBILITY OF USG ESPECIALLY CONCERNING CIA ACTIVITIES AND OUR SUPPORT FOR REGIMES THAT SEVERELY RESTRICT HUMAN RIGHTS. CHARGE REPLIED UNFORTUNATELY HOST COUNTRIES IN MORLD TODAY RESTRICT AND VIOLATE HUMAN RIGHTS. BUT THAT DEPARTMENT HAS TAKEN LEAD IN
