1. US ATTORNEY HAAS AND GUYANESE COURT MARSHAL INFORMED CONSUL ON SEPTEMBER 9 THAT FURTHER ATTEMPT BY GUYANESE COURT MARSHAL TO SERVE SUMMONS ON PEOPLE'S TEMPLE LEADER JIM JONES WAS UNSUCCESSFUL. HAAS STATED THAT HE ACCOMPANIED COURT MARSHAL AND TWO POLICE OFFICERS TO JONESTOWN WHERE GROUP MET WITH HOSTILE RECEPTION.
2. COURT MARSHAL RELATED TO CONSUL THAT REPRESENTATIVE OF PEOPLE'S TEMPLE REFUSED TO ACCEPT SUMMONS, AND WHEN MARSHAL AS INSTRUCTED BY COURT MAILED THREE COPIES OF THE SUMMONS ON DIFFERENT BUILDINGS THEY WERE TORN DOWN BY PEOPLE'S TEMPLE MEMBER AND THROWN BACK INTO THE GROUP'S LAND ROVER. MARSHAL ALSO ATTEMPTED TO SERVE ADDITIONAL COPY OF THE SUMMONS ON PEOPLE'S TEMPLE REP., BUT SHE REFUSED TO ACCEPT IT. THE SUMMONS FELL ON THE GROUND AND MEMBERS OF THE PEOPLE'S TEMPLE THEN ACCUSED THE GROUP OF LITTERING THE AREA WITH QUOTE GARBAGE AND TRASH UNQUOTE. AT THIS POINT THE GROUP WITHDREW.

3. CONSUL WAS PRESENT AT COURT HEARING ON SEPTEMBER 10. NO MEMBER OF THE PEOPLE'S TEMPLE APPEARED NOR WERE ANY OF THEIR LEGAL REPRESENTATIVES PRESENT. SUPREME COURT JUSTICE WHO HAS JURISDICTION IN THIS CASE BECAME VISIBLY ANGRY WHEN COURT MARSHAL RELATED SCENARIO TO HIM. HE ISSUED ORDER FOR THE ARREST OF THE CHILD JOHN STOEN FOR THE PURPOSE OF BRING HIM INTO CUSTODY OF THE COURT IN GEORGETOWN. HE FURTHER DIRECTED JONES TO BE SUMMONED TO APPEAR IN COURT TO SHOW CAUSE WHY HE SHOULD NOT BE HELD IN CONTEMPT, AND FINALLY IF JONES FAILS TO APPEAR HE WILL BE TAKEN INTO CUSTODY FORTHWITH.

4. IN UNRELATED ISSUE, HAAS TOLD CONSUL THAT HE, HAAS, HAD BEEN INFORMED BY HIS CLIENT DURING A TELEPHONE CONVERSATION ON SEPTEMBER 9, THAT JONES' ATTORNEY CHARLES GARRY ANNOUNCED TO THE PRESS IN SAN FRANCISCO THAT JONES PLANS A MULTIMILLION DOLLAR SUIT AGAINST THE US FOR CONSPIRACY. HAAS HAD NO FURTHER INFORMATION ON THIS. HAAS ALSO

CLAIMED THAT HIS CLIENT TOLD HIM THAT THE PEOPLE'S TEMPLE
HAD RELEASED A STATEMENT TO THE PRESS ABOUT AN
ASSASSINATION ATTEMPT ON JONES SHORTLY AFTER HAAS GROUP
LEFT JONESTOWN ON SEPTEMBER 6. WHEN PRESSED BY ONE OF
THE POLICE OFFICERS WHO WERE AT JONESTOWN ABOUT THIS
ALLEGED ATTEMPT, PEOPLE'S TEMPLE MEMBERS FASTILY BACK-
TRACKED BECAUSE THEY HAD PREVIOUSLY MAINTAINED JONES
HAD NOT BEEN IN THE AREA ON SEPTEMBER 6.

5. CONSUL INTENDS TO INFORM DIRECTOR SCA, AND OTHER
ACCOMPANYING SCS OFFICIALS OF CASE AT PORT
OF SPAIN CONSULAR CONFERENCE.
