1. PEOPLE'S TEMPLE ATTORNEY LIONEL LUCKHOOD INFORMED COMMISSION OF SUPERVISOR TO THAT HEARINGS HAVE BEEN COMPLETED ON MOTION REPORTED REPEL. LUCKHOOD STATED THAT JUDGE WILL MAKE HIS OPPOSING ARGUMENTS AND RENDER HIS DECISION LATE THIS WEEK.

2. LUCKHOOD STATED HE BELIEVES THAT JUDGE WILL RUL IN HIS FAVOR. HE CLAIMED THAT HE HAS NEVER SEEN A CASE WITH SO MANY LEGAL ERRORS. LUCKHOOD CITED THE FOLLOWING AS ERRORS. (A) THE LACK OF PERSONAL SERVICE ON JONES. JEFFREY BASS' (MR. STOEN'S U.S. ATTORNEY) AFFIDAVIT ATTESTING TO JONES' ATTEMPTS TO AVOID SERVICE WAS NOT SPECIFIC ENOUGH. THE AFFIDAVIT DID NOT IDENTIFY THE POLICE OFFICERS WHO PURPORTEDLY SAW JONES AT THE HOME EARLIER THE SAME DAY. THEREFORE, IT CANNOT BE PROVEN THAT JONES WAS TRYING TO AVOID SERVICE. (B) THE ORDER TO ARREST JOEN STOEN HAS NO BASIS OF JURISDICTION UNDER GUYANESS LAW BECAUSE THIS IS NOT DONE IN GUYANA. (C) THE QUESTIONABLE ADMISSIBILITY AND ENFORCEABILITY OF THE CALIFORNIA COURT

ORDER IN GUYANA REGARDING GRACE STOEN CUSTODY OF HER CHILD WHEN NEITHER PARENT IS PRESENT IN GUYANA. (D) THE HASTE IN WHICH THE WHOLE JUDICIAL PROCEDURE WAS CARRIED OUT WAS VERY UNUSUAL UNDER GUYANESS LAW.

3. WHETHER LUCKHOOD'S ARGUMENTS WILL CONVINCE THE JUDGE IS UNKNOWN AT THIS TIME. HE IS A FORTIDABLE OPPOSER WHO WILL NO DOUBT PRESENT HIS CASE EFFECTIVELY. LUCKHOOD CONFIDED TO CONSUL THAT HE WAS CERTAIN HE WOULD WIN BECAUSE CASE HAS BEEN MISMANAGED BY JUDGE IN HIS HASTE TO RESOLVE MATTER QUICKLY.
