1. POST WOULD APPRECIATE DEPARTMENT PASSING THE FOLLOWING INFORMATION TO _____

WE HAVE VERIFIED WITH THE GUYANESE IMMIGRATION SERVICE THAT FARRIS ENTERED GUYANA ON JULY 29, 1977. HE IS PRESENTLY RESIDING AT THE PEOPLE'S TEMPLE AGRICULTURAL COMMUNITY NEAR PORT KAITUMA IN GUYANA'S NORTHWEST DISTRICT.
2. POST RECEIVING SOCIAL SECURITY CHECKS FOR FARRIS ADDRESSED TO MISSION VILLAGE, P.O. BOX 893, GEORGETOWN. THIS IS THE MAILING ADDRESS OF THE PEOPLE'S TEMPLE IN GUYANA. A MEMBER OF THE PEOPLE'S TEMPLE INFORMED CONSUL THAT FARRIS IS AT THE AGRICULTURAL COMMUNITY AND PURPORTEDLY IN GOOD HEALTH.
3. ANYONE CAN TRAVEL TO GUYANA'S NORTHWEST DISTRICT ALTHOUGH ARRANGEMENTS FOR GROUND TRANSPORTATION AND LODGING MUST BE MADE PRIOR TO THE JOURNEY. THE DISTANCE FROM MATTHEW'S RIDGE, TO CENTER OF THE DISTRICT, TO THE FARM IS ABOUT THIRTY FIVE MILES BUT THE JOURNEY TAKES ABOUT AN HOUR AND FIFTEEN MINUTES EACH WAY. HOTEL ACCOMMODATIONS ARE BELOW U.S. STANDARDS. THE TRAVELLER WOULD HAVE TO REMAIN IN MATTHEW'S RIDGE

AN ADDITIONAL FORTY EIGHT HOURS FOR THE RETURN FLIGHT TO GEORGETOWN. ALTERNATIVELY, IF THE RELATIVE WAS WILLING TO PAY ABOUT US\$350 FOR A CHARTERED PLANE THE TRIP COULD BE ACCOMPLISHED IN FOUR TO FIVE HOURS.

4. ALL PEOPLE'S TEMPLE MEMBERS ARE RECEIVING "LANDED IMMIGRANT STATUS" IN GUYANA AND ARE REGISTERED WITH THE GUYANESE IMMIGRATION SERVICE. THE EMBASSY IS CURRENTLY ASSISTING THE PEOPLE'S TEMPLE IN HANDLING THE ARRANGMENTS OF A RECENT DEATH OF ONE OF THE MEMBERS OF THE GROUP. SPECIFICALLY, WE ARE ADVISING THEM ON THE PROPER NOTIFICATION PROCEDURES TO BE USED LOCALLY IN THE EVENT OF A DEATH AND OF THE REPORTING REQUIREMENTS OF THE EMBASSY. CONSUL HAS ADVISED THE ORGANIZATION OF SOCIAL SECURITY ADMINISTRATION (SSA) DEATH BENEFITS THAT RELATIVES OF THE DECEASED MAY BE ENTITLED TO. PEOPLE'S TEMPLE HAS ALSO REGISTERED ONE BIRTH WITH THE EMBASSY AND PLANS TO REGISTER A SECOND CHILD WHO, IRONICALLY, WAS BORN TO THE FAMILY OF THE DECEASED WITHIN TWENTY FOUR HOURS OF HIS DEATH.

2. DEPARTMENT MAY ALSO WISH TO INFORM [REDACTED] THAT
WE WILL BE VERIFYING THE RELATIVE'S HEALTH AND WELL BEING
SOME TIME IN JANUARY, 1975 UNLESS AN EMERGENCY DEVELOPS TO
WARRANT AN EARLIER TRIP TO THE REGIONAL DEPARTMENT

3. WE WOULD LIKE TO ADVISE THAT SHOULD MR. FARRIS
DIE IT WOULD BE UNLIKELY THAT PEOPLE'S TEMPLE COULD CASH
HIS RETIREMENT CHECKS SINCE THE ORGANIZATION HAS NOT BEEN
DESIGNATED AS HIS REPRESENTATIVE PAYEE BY SSA. THUS, FARRIS
MUST ENDORSE EACH CHECK BEFORE IT CAN BE CASHED.

"COLLISION". POST RECEIVED FIFTY TWO SOCIAL SECURITY CHECKS
THIS MONTH FOR RETIREES RESIDING AT THE FARM AND WE ANTICIPATE
THIS NUMBER WILL PROBABLY DOUBLE WITHIN THE NEXT FEW MONTHS.

6. UNTIL WE CAN HAVE A CONSULAR OFFICER VISIT THE FARM
WITHIN THE NEXT TWO TO THREE MONTHS IT WILL BE DIFFICULT TO
CONTACT FARRIS DIRECTLY AS REQUESTED PARA THREE REPEL.
CONSUL IN CONVERSATION ON NOVEMBER 9 WITH PEOPLE'S TEMPLE
MEMBER ASKED ABOUT FARRIS WITHOUT GOING INTO ANY DETAILS. HE
WAS ASSURED BY THE INDIVIDUAL THAT TO THE BEST OF HER
KNOWLEDGE FARRIS WAS WELL AND HAPPY. PEOPLE'S TEMPLE
REPRESENTATIVES ALSO IMMEDIATELY ASSUMED FAMILY IN U.S. WAS
INTERESTED ABOUT HIM AND PROMISED TO RELAY MESSAGE TO HIM OF
FAMILY'S CONCERN.

7. DEPARTMENT MAY WISH TO DRAW UPON THE ABOVE INFORMATION
TO RESPOND TO SIMILAR REQUESTS FOR GENERAL INFORMATION ABOUT
MEMBERS OF THE COMMUNITY. WHEN CONOFF VISITS SITE HE WILL
REQUEST PRIVATE, PERSONAL CONTACT WITH ALL INDIVIDUALS WHO
HAVE BEEN SUBJECT OF SAID INQUIRIES. WE HAVE FOUR SUCH
REQUESTS PENDING.
