WITH THEIR LIFE AT THE COMMUNITY. THE CONSUL NOTED THAT [REDACTED] E B6
THEY HAD NOT BEEN GUT OFF FOR DISCIPLINARY REASONS. [REDACTED] E B6
TOLD THE CONSUL SHE IS BUSY WITH SCHOOL AND SPORTS. [REDACTED] E B6
STARTING THE EQUIPMENTS OF FARMING. MRS. HOWARD INDICATED SHE WAS E B6
NOT CERTAIN WHEN SHE WOULD BE RETURNING TO THE UNITED STATES. E B6
2. THE CONSUL GAVE [REDACTED] YOUR LETTER AND MENTIONED YOUR CONCERN FOR THEIR WELL BEING. MRS. HOWARD EXPRESSED SURPRISE E B6
THAT YOU SHOULD BELIEVE THAT [REDACTED] THERE WERE E B6
BEING HELD AGAINST THEIR WILL. SHE IMMEDIATELY DENIED THIS E B6
ALLEGATION AND INFORMED THE CONSUL THAT SHE WAS VERY HAPPY E B6
AND CONTENT AT JONESTOWN.

3. CONSUL ALSO PASSED [REDACTED] SOCIAL SECURITY E B6
CHECKS TO HER. AT THAT TIME HE ASKED ABOUT HER WELL BEING E B6
AND FUTURE PLANS. MRS. THOMPSON REPLIED THAT SHE WAS E B6
FEELING FINE AND WAS ENJOYING HER STAY IN JONESTOWN VERY E B6
MUCH. SHE ALSO DENIED BEING HELD AGAINST HER WILL AND E B6
EXPRESSED NO DESIRE TO RETURN TO THE UNITED STATES AT THIS E B6
TIME.

4. THE CONSUL MENTIONED TO [REDACTED] YOUR DESIRE E B6
TO VISIT HER AT JONESTOWN. MRS. HOWARD RESPONDED THAT SHE WOULD E B6
BE HAPPY TO SEE YOU. I HOPE THAT ABOVE INFORMATION CLARIFIES E B6
YOUR RELATIVES' SITUATION AND THEIR PRESENT AND FUTURE E B6
DESIRERS. PLEASE FEEL FREE TO CONTACT THE CONSUL IF YOU E B6
HAVE ANY FURTHER QUESTIONS.
