1. DEPARTMENT CAN APPRECIATE THE UNIQUENESS OF THE SITUATION DESCRIBED IN REF TEL AND THE PROBLEMS POST HAS ENCOUNTERED IN ATTEMPTING TO DEAL WITH THIS SITUATION.
2. WE AGREE WITH POST'S POSITION SET FORTH IN PARAGRAPH 6 OF REF TEL AND CONCUR THAT HOST GOVERNMENT HAS GOVERNMENTAL JURISDICTION OVER U.S. CITIZENS AND OTHER ALIENS RESIDING WITHIN ITS BOUNDARIES. DEPARTMENT ASSUMES THAT BOTH THE GUYANESE GOVERNMENT AND THE LEADER OF THE PEOPLES TEMPLE ARE AWARE THAT THE COMMUNITY IS UNDER THE JURISDICTION OF THE GOG AND THAT ALL MEMBERS OF THE COMMUNITY ARE SUBJECT TO THE LAWS AND AUTHORITY OF THE GOG.
