2. IN REGARD TO POINTS RAISED IN REFTEL B DESK OFFICER HAS BEEN IN DAILY CONTACT WITH MS. SPEIERS AND HAS MET WITH SCOLLAERT AND SMEETAN TO DISCUSS VISIT. PROBLEMS IN PARA'S 2 AND 3 OF REFTEL B HAVE BEEN EMPHASIZED PARTICULARLY TO MS. SPEIERS. DESK OFFICER DRAWING UPON HIS PERSONAL KNOWLEDGE OF BOTH AREA AND PROBLEM HAS GRAPHICALLY PORTRAYED SITUATIONS THAT COULD ARISE. DESK OFFICER ALSO HAS POINTED OUT LIMITS OF EMBASSY AUTHORITY OVER PRIVATE AMERICAN CITIZENS IN A FOREIGN COUNTRY.

J. DESK OFFICER BRIEFLY DISCUSSED CODEL DURING LUNCHEON WITH GUYANESE CHARGE ON NOVEMBER 2. HE MENTIONED TO CHARGE (WHO WAS AWARE OF VISIT) THAT RYAN AS A MEMBER OF HIRC HAS OVERSIGHT RESPONSIBILITY ON USG CONDUCT OF FOREIGN RELATIONS. DESK OFFICER RECOMMENDED TO CHARGE THAT IT WAS IN BEST INTEREST OF HIS GOVERNMENT TO FACILITATE VISIT WHERE POSSIBLE.
