2. DEPARTMENT HAS GIVEN COPY OF REF C TO CODEL AND UNDERSTANDS CODEL HAS DISCUSSED CONDITIONS IN PARA 4 WITH PEOPLE'S TEMPLE (PT) LAWYER MARK LANE. LANE CANNOT BE PRESENT FOR CODEL VISIT. SINCE RYAN'S SCHEDULE IS TIGHT, HE CANNOT CHANGE VISIT DATE, AND WILL TRAVEL TO GEORGETOWN FOR DISCUSSIONS WITH EMBASSY AND GOG OFFICIALS, EVEN IF CODEL CANNOT VISIT JONESTOWN AND PT. EMBASSY REQUESTED SCHEDULE APPOINTMENTS WITH APPROPRIATE GOG AND EMBASSY OFFICIALS.

3. IN EVENT CODEL IS ABLE VISIT JONESTOWN AND PT, CODEL IS AUTHORIZED TO CHARTER AN AIRPLANE AND MAKE WHATEVER LAND TRANSPORTATION ARRANGEMENTS ARE NECESSARY. EMBASSY SHOULD RESERVE AIRPLANE AND NECESSARY LAND TRANSPORTATION, IF ADVANCE RESERVATIONS ARE NECESSARY.

4. AFTER CAREFUL CONSIDERATION LEGAL ADVISER'S OFFICE SAYS ITS UNABLE TO SEND LAWYER WITH CODEL BECAUSE OF HEAVY WORK LOAD AND SERIOUS TRAVEL RESTRICTIONS. HOWEVER, JACKIE SPEIER AND JAMES SCOLLAERT ARE TO BE THOROUGHLY BRIEFED BY L AND SCS
