I HAVE JUST RETURNED FROM A MEETING WITH PRIMIN BURNHAM, DEPUTY PRIMIN REID, FORMIN JACKSON, AND MINISTER OF INFORMATION SHIRLEY FIELD-RIDLEY. VARIOUS OFFICERS OF THE GUYANA DEFENSE FORCE WERE ALSO IN ATTENDANCE. CREWS OF THE TWO CHARTER AIPCRAFT WHICH HAD FEEN SHOT AT DURING THE INCIDENT AT PORT KAITUMA HAD JUST ARRIVED AND WERE ALSO PRESENT. FOLLOWING RECONSTRUCTION OF INCIDENT IS BASED ON THEIR TESTIMONY WHICH MUST BE USED CAREFULLY IN VIFW OF THEIR UNDERSTANDABLY EMOTIONAL STATE.

2. BOIF CHARTER AIRCRAFT HAD ARRIVED AT PORT KAITUMA AND HAD COMMENCED LOADING CONGRESSMAN BYAN'S PARTY. THE SMALLER OF THE TWO, A FIVE-PASSENGER CESSNA, HAD ALREADY LOADED APPAPENTLY, WITH AT LEAST TWO OR THREE OF THE JONESTOWN APPAPENTLY, WITH AT LEAST TWO OR THREE OF THE JONESTOWN RESIDENTS WHO HAD ELECTED TO LEAVE THE COMMUNITY WITH LIMITED OFFICIAL USE LIMITED OFFICIAL USE PAGE 02 GEORGE 03776 1903267 CONGRESSMAN RYAN, AMONG ITS FIVE PASSINGERS. ACCORDING TO THE PILOT ONE OF THE INDIVIDUALS PRODUCED A PISTON AND BEGAN FIRING WITHIN THE AIRCRAFT AT THE OTHER PASSENGERS. AT ALMOST THE SAME TIME A TRACTOR PULLING A CART APPEARED ON THE SCENE. THE CART WAS LOADED WITH SEVERAL PROPLE AND WEEN IT APPROACHED THE AIRCRAFT THE INDIVIDUALS IN THE CART BEGAN FIRING AT THE CLUSTER OF PEOPLE WHO HAD NOT YET BOARDED THE SECOND LARGER AIRCRAFT.
SEVERAL OF THE PEOPLE. ACCORDING TO THE PILOTS, WERE
IMMEDIATELY STRUCK BY BULLETS AND IT THEIR ESTIMATION
WERE KILLED DURING THE FIRST FUSILLADE. THIS GROUP INCLUDED CONCRESSMAN RYAM AND MEMBERS OF THE NBC CAMERA TEAM. THE FIRING ALSO DAMAGED THE ENGINES OF THE SECOND AIRCRAFT AND RENDERED IT UNFLYABLE. PEOPLE STIP ON THE GROUND WHO WERE NOT WOUNDED OR WERE WOUNDED AND PEOPLE STILL AMBULATORY RAM INTO THE BUSHES SURROUNDING THE AIRSTQIP TO ESCAPE THE FIRE. 3. NEITHER CREW HAD ANY GREAT FAMILIATITY WITH THE MANAGED TO TAKE OFF WITH INDIVIDUAL PASSENGERS WITH THE EXCEPTION OF THE CONGRESSMAN. THE NEC CAMERA TEAM AND THE DCM AND THUS COULD NOT READILY IDENTIFY CASUALTIES. THEY DID REPORT, HOWEVER, THAT WHEN THEY LFFT PORT KAITUMA THE DCM SFEMED TO BE AMBULATORY BUT PERHAPS SLIGHTLY WOUNDED. THE CONGRESSMAN AND THE CAMERA TEAM APPEARED TO BE DEAD. 4. AFTER THE MEETING WITH THE PRIMIN THE AIR
CREWS WERE TAKEN IN CHARGE BY THE COMMISSIONER OF POLICE
FOR A MORE INTENSIVE DEFRIEFING. I HAVE SENT AN EMBASSY
POLITICAL OFFICER TO BE PRESENT AT THIS SESSION.
5. UNITS OF THE GUYAMA DEFENSE FORCE AND THE POLICE ARE BEING AIRLITTED DURING NIGHT FOURS TO MATTHEWS BIDGE. THE CLOSEST AIRSTRIP CAPABLE OF TAKING AIRCRAFT AFTER DARK. GDF IS ALSO POSITIONING TOW HTLICOPTERS AT MATTHEWS RIDGE IN ORDER TO BE ABLE TO SHUTTLE TROOPS INTO PORT KAITUMA AT FIRST LIGHT. THERE IS ALREADY A SMALL GDF UNIT AT PORT KAITUMA NUMBERING PERHAPS NO MORE THAN SIY. AS OF NOW THERE IS NO COMMUNICATION LINK WITH PORT KAITUMA. 6. THE PRIMINISTER EXPRESSED HIS DEEP REGRET OVER THIS TRAGEC INCIDENT AND VISHED THIS TO BE CONVEYED URGENTLY TO USG. HE NOTED THAT HIS GOVERNMENT HAD BEEN MOST FACILITATIVE REGARDING THE CODEL'S VISIT.

7. I TOLD THE PRIME MINISTER THAT OUR IMMEDIATE CONCERNS
WERE AS FOLLOWS: (1) THAT THE GOG MAKE EVERY EFFORT
TO GET INTO PORT KAITUMA TO FURNISH AID, ASSISTANCE AND PROTECTION TO THE AMERICANS WHO WERE STILL THERE.
(2) THAT AS SOON AS POSSIFLE THE BODIES OF THE DEAD SHOULD BE BROUGHT TO GEORGETOWN, AND (3) THAT THE PERPETRATORS OF THIS OUTRAGE BE BROUGHT TO JUSTICE AS SOON AS POSSIFLE. 3. I LEFT THE PRIMT MINISTER'S OFFICE AT THIS POINT AND RETURNED TO THE EMBASSY.
